RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA TO SIGN A MEMORANDUM OF AGREEMENT FOR THE TRANSFER OF FUNDS TO THE BARANGAYS, ACCREDITED CIVIL SOCIETY ORGANIZATIONS, DIFFERENT SCHOOLS AND LIGA NG MGA BARANGAY FOR THE VARIOUS REQUESTS FOR FINANCIAL ASSISTANCE FROM 20% DEVELOPMENT FUND, SPECIAL EDUCATION FUND AND EXECUTIVE SERVICES DONATIONS.

WHEREAS, in a letter dated December 20, 2021, the Hon. Mayor, Atty. Suzette T. Alquisada, requested this August Body for the urgent passing of a *"Resolution Authorizing The Municipal Mayor To Sign Memorandum Of Agreement For The Transfer Of Funds To The Barangays, Accredited Civil Society Organizations, Different Schools And Liga Ng Mga Barangay For The Various Requests For Financial Assistance From 20% Development Fund, Special Education Fund And Executive Services Donations;"*

WHEREAS, as provided under the Local Government Code, Local Government Units are mandated to address the needs of their constituencies, and empower the people through direct participation in the affairs of government, by allowing them the widest possible apace to decide on, initiate, implement, and innovate on development activities that address their identified needs;

WHEREAS, as convergence strategy, the Municipal Government of Tigbauan recognizes and appreciates the efforts and participation of the different Barangays, Accredited Civil Society Organizations, different schools and Liga Ng Mga Barangay in responding to the needs of their learners/constituents;

WHEREAS, the Municipality of Tigbauan has appropriated funds from 20% development funds, Special Education Fund and Donations-Executive Services for the implementation of infrastructure and socio-cultural projects of the different Barangays, Accredited Civil Society Organizations, Different Schools and Liga Ng Mga Barangay in this municipality;

WHEREAS, pursuant to Section 444 (a) and (b) (vi) of the Local Government Code, there is a need to authorize the Municipal Mayor to enter into a Memorandum of Agreement with the different Barangays, Accredited Civil Society Organizations, Different Schools and Liga Ng Mga Barangay in order for them to immediately effect the release/transfer of funds for their various projects;

WHEREAS, through this grant of authority, the fast and efficient delivery of services will be ensured for the benefit and general welfare of the people of Tigbauan;

WHEREAS, to assure full transparency and accountability, the Local Chief Executive shall periodically update the local Sanggunian of the projects and programs that LGU Tigbauan undertakes in partnership with the different Barangays, Accredited Civil Society Organizations, Different Schools and Liga Ng Mga Barangay;

NOW, THEREFORE, on joint motion of HON. JERRY T. TUARES, *Chairman, Committee on Barangay Affairs* and HON. DENNIS T. VALENCIA, *Chairman, Committee on Appropriations, Budget, Finance and Accounts* and duly seconded by Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada to Sign a Memorandum of Agreement for the Transfer of Funds to the Barangays, Accredited Civil Society Organizations, Different Schools and Liga Ng Mga Barangay for the Various Requests for Financial Assistance from 20% Development Fund, Special Education Fund and Executive Services Donations;
