WHEREAS, as discussed by the Hon. Mayor in her letter dated January 11, 2022, the corrected Plantilla is pursuant to Budget Circular No. 2021-2 dated August 25, 2021, Modification of Nurse Positions and as per Memorandum from the Office of the President dated June 1, 2021 pursuant to Section 32 of Republic Act No. 9173 or the Philippine Nursing Act of 2002. For Nurse II occupied by Santillana, Joji, as per above-mentioned budget circular, she will be having SG 16 Step 8, effective January 1, 2022, and effective July 1, 2022, she will be having SG 17-8 pursuant to provisions in Section 30 of RA 7305: Magna Carta for Public Health Workers *"Three (3) months prior to the compulsory retirement, the public health worker shall automatically be granted one (1) salary range or grade higher than his/her basic salary and his/her retirement benefits thereafter, computed on the basis of his/her highest salary: Provided, That he/she reached the age and fulfilled service requirements under existing laws." Miss Santillana will be compulsory retiring in September 8. 2022;*

WHEREAS, further, when her opinion was solicited on whether to pass a resolution or an appropriation ordinance in amending said CY 2022 Plantilla of LGU Personnel as reflected in the Appropriation Ordinance No. 2021-005, "An Ordinance Enacting The Fiscal Year 2022 Annual Budget For General Fund Amounting To Two Hundred Sixty One Million Five Hundred Thousand Pesos (P261,500,000.00), Special Education Fund In The Amount Of Four Million Pesos (P4,000,000.00) And Special Account From The General Fund Amounting To Nine Million Five Hundred Thousand Pesos (P9,500,000.00) For The Operation Of Market And Slaughterhouse Of The Municipality Of Tigbauan, Province Of Iloilo," approving the Municipal Annual Budget for FY 2022, the Municipal Mayor explained that since the amendment did not alter or change the position title only the name of incumbent, SG/Step and Amount were properly indicated and there is no change in the appropriated amount in the Personal Services; therefore passing of a resolution is valid for such correction. The Municipal Budget Officer and the Human Resource Management Officer concurred for such correction in the Plantilla for the Rural Health Office;
