RESOLUTION CONFORMING AND APPROVING THE CY 2021 SUPPLEMENTAL BUDGETS OF BARANGAYS DAPDAP, BAGACAY, SAN RAFAEL AND ISIAN, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on January 11, 2022 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2021 Supplemental Budgets of Barangays Dapdap, Bagacay, San Rafael and Isian, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2021 Supplemental Budgets of the following barangays, to wit:

*The appropriation of **Brgy. Dapdap** for Supplemental Budget No. 2021-02 embodying Appropriation Ordinance No. 2021-01 in the amount of **P33,000.00** is for the Payment of Service Recognition Incentives to Government Employees for Fiscal Year 2021 as per Administrative Order No. 45, Series of 2021 chargeable against CY 2021- MOOE Savings – 33,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Bagacay** for Supplemental Budget No. 2021-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P43, 000.00** is for the Payment of hazard pay of Brgy. Volunteers, Elective and Appointed Officials who rendered service during the period of Enhanced Community Quarantine (ECQ) and Modified Enhanced Community Quarantine (MECQ) for the year 2021 as per Administrative Order 43 dated June 1, 2021 chargeable against CY 2021- PS Savings-15,600.00 and MOOE Savings- 27,400.00 of the aforementioned barangay.*

*The appropriation of **Brgy. San Rafael** for Supplemental Budget No. 2021-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P17,490.00** is for the Payment of Service Recognition Incentives to Government Employees for Fiscal Year 2021 as per Administrative Order No. 45, Series of 2021 chargeable against CY 2021-MOOE Savings-17,490.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Isian** for Supplemental Budget No. 2021-02 embodying Appropriation Ordinance No. 2021-01 in the amount of **P24,200.00** is for the Payment of Service Recognition Incentives to Government Employees for Fiscal Year 2021 as per Administrative Order No. 45, Series of 2021 chargeable against CY 2021-PS Savings-4,200.00 and MOOE Savings-20,000.00 of the aforementioned barangay.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Barangay Supplemental Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;


