RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO APPLY FOR **ACCRETION PATENT** FOR TIGBAUAN NURSERY AND BEACH FOREST LOCATED AT BARANGAY 9, POBLACION, TIGBAUAN, ILOILO.

WHEREAS, Section 16 of the Local Government Code, states that, "*Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare*";

WHEREAS, it is one of the priority programs of the present administration that all public lands within its jurisdiction and under its possession, control and supervision shall be titled in the name of the Municipality of Tigbauan;

WHEREAS, the LGU has identified a public land containing a total land area of Nineteen Thousand Eight Hundred Twenty Seven (19,827) square meters situated at the right tip portion of the Sibalom River at Brgy. 9, Pob., Tigbauan, Iloilo, to be utilized for the establishment of the Tigbauan Nursery and Beach Forest;

WHEREAS, said Nursery & Beach Forest which serves as a site of various activities relevant to the conservation of the environment such as tree planting and clean-up programs has already been indicated in the 2014 - 2024 Comprehensive Land Use Plan of the Municipality of Tigbauan;

WHEREAS, there is a need for the Municipality of Tigbauan to apply for the accretion patent of the said site/parcel of land situated at the right tip of the Sibalom River, Brgy. 9, Pob. of this municipality;

NOW, THEREFORE, on motion of HON. JULIUS T. LEDESMA, Vice Chairman, Committee on Environmental Protection, Housing, Land Utilization, Zonification, Assessment and Expropriation, (*under the sponsorship of Hon. Ma. Gerrylin Santuyo-Camposagrado, Committee Chairperson*) and duly seconded by Hon. Neri T. Camiña, Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

BE IT RESOLVED, as it is hereby RESOLVED, to pass a Resolution Authorizing the Municipal Mayor, Atty. Suzette T. Aquisada, for and in behalf of the Municipality Of Tigbauan, to apply for Accretion Patent for the Tigbauan Nursery and Beach Forest Located at Barangay 09 Poblacion, Tigbauan, Iloilo.”
