RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRANCIA-ALQUISADA, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A CONTRACT OF SERVICES FOR THE ENGAGEMENT OF THE SERVICES OF MR. KEVIN P. PIAMONTE AND KENNETH DE LA CRUZ FOR THE SHORT DOCUMENTARY FILM REGARDING LIBERATION OF PANAY.

WHEREAS, the Local Chief Executive in a letter dated March 7, 2022 requested this Sangguniang Bayan for the URGENT passing of a *“Resolution Authorizing the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan to Enter Into a Contract of Services for the Engagement of the Services of Mr. Kevin P. Piamonte and Kenneth De La Cruz for the Short Documentary Film Regarding Liberation of Panay;”*

WHEREAS, said **Contract of Service** shall be made and entered into by, and between the following parties:

- The **MUNICIPALITY OF TIGBAUAN**, a local government unit with office address at Tejero St., Tigbauan, Iloilo represented by its Local Chief Executive, ATTY. **SUZETTE T. ALQUISADA**, as “FIRST PARTY”; and
- **KEVIN P. PIAMONTE** and **KENNETH DE LA CRUZ** of legal ages, Filipinos and with residence/office address at 148 Interior, M.H. del Pilar, Molo, Iloilo City, Philippines, as “SECOND PARTY”;

WHEREAS, the LGU is in need of the services of KEVIN P. PIAMONTE and KENNETH DE LA CRUZ who shall perform work for a short documentary film in relation to “Liberation of Panay;”

WHEREAS, KEVIN P. PIAMONTE and KENNETH DE LA CRUZ have signified their intentions, to which the LGU has accepted, to provide the services needed by the latter;

WHEREAS, Mr. Piamonte and Mr. De La Cruz possess the education, experience and skills required to perform the documentary film in relation to “Liberation of Panay;”

WHEREAS, Mr. De La Cruz is contracted as Director of Photography, Editor and Researcher for the above-mentioned documentary film to be paid in the amount P3,000.00 per day for a period of fifty (50) days to start on March 10, 2022;

WHEREAS, Mr. Piamonte is contracted as writer, director and producer for the above-mentioned documentary film to be paid also in the amount P3,000.00 per day for a period of fifty (50) days to start on March 10, 2022;

WHEREAS, the contract includes the compilation, gathering and validation of facts regarding the Liberation of Panay;

WHEREAS, it is understood that this contract does not create an employer and employee relationship between the LGU and Mr. Piamonte and Mr. De La Cruz, that the services rendered are not considered as bases for entitlements to leave privileges and other benefits enjoyed by the regular personnel of the LGU, such as but not limited to PERA, ACA and RATA;

WHEREAS, notwithstanding the fixed duration of this contract, the services of Mr. Piamonte and Mr. De La Cruz may be terminated earlier than the expiration date due to unsatisfactory service, unavailability of funds, early completion or discontinuance of the project, or other reasons within the control of both of them;


NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, Chairman, Committee on Education, Tourism and Civil Service *jointly* with the Committee on Appropriations, Budget, Finance & Accounts, chaired by HON. DENNIS T. VALENCIA and duly seconded by Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to authorize the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan to Enter Into a Contract of Services for the Engagement of the Services of Mr. Kevin P. Piamonte and Kenneth De La Cruz for the Short Documentary Film Regarding Liberation of Panay;
