Resolution No. 2022-023

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE TENEFRENCIA-ALQUISADA FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY (ISAT U), ILOILO CITY FOR THE ON-THE-JOB TRAINING (OJT) PROGRAM FOR STUDENTS.

WHEREAS, the Local Chief Executive in a letter dated March 10, 2022 requested this Sangguniang Bayan for the URGENT passing of a *“Resolution Authorizing the Municipal Mayor, Atty. Suzette Tenefrancia-Alquisada, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan to Enter Into a Memorandum of Understanding (MOU) with the Iloilo Science and Technology University (ISAT U), Iloilo for the On-The-Job Training (OJT) Program for Students,”*

WHEREAS, said **Memorandum of Understanding** shall be made and entered into by, and between the following parties:

- The **ILOILO SCIENCE AND TECHNOLOGY UNIVERSITY (ISAT U)**, a public institution of higher learning, organized and existing under R.A. 10595, with office address at Burgos St., La Paz, Iloilo City, Philippines, represented by **DR. RAUL F. MUYONG, UNIVERSITY PRESIDENT III**, as “FIRST PARTY”; and
- The **MUNICIPALITY OF TIGBAUAN**, a local government unit with principal office address at Tejero St., Tigbauan, Iloilo represented by its Local Chief Executive, **ATTY. SUZETTE T. ALQUISADA**, as “SECOND PARTY”;

WHEREAS, having affirmed their common commitment to the values of intellectual freedom, educational excellence, and skills development for global competitiveness among the youth, ISAT U and Partnered Industry hereby execute this Memorandum of Understanding as

partners in the implementation of Community-Based Student Internship Program for AY **2021-2022** with the following mechanics:

I. PURPOSE

The purpose of this Agreement is to develop academic cooperation and promote mutual understanding between the two Parties in the implementation of Community-based Student Internship Program for AY 2021 – 2022 to be participated in by graduating ISAT U students.

II. SCOPE OF COOPERATION

Both Parties agree to consider the development of mutually beneficial collaborations in the implementation of Community-based Student Internship Program for AY 2021 –2022, including but not limited to the following:

- 1. Mutual cooperation in the deployment of graduating students of ISAT U who need to undergo their Community-based Student Internship Program for AY 2021– 2022 within the territorial jurisdiction of Partnered Industry.*
- 2. Establish cooperation and support with one another in the implementation and monitoring of the forty percent (40%) Community-based component of the Student Internship Program and its sixty percent (60%) Home-based alternative activities.*
- 3. ISAT U shall assign Student Internship Program (SIP) Coordinators/ Supervisors while the Partnered Industry will assign personnel to serve as their counterpart. Together they will determine the requirements to be complied with by the students who are deployed within the area of jurisdiction of Partnered Industry.*
- 4. Both Parties shall establish security plans and health protocol to secure and protect the SIP Students deployed in the area under the control of Partnered Industry.*

III. MECHANICS OF IMPLEMENTATION

- 1. Prior to the implementation of the Community-based Student Internship Program for AY 2021 – 2022, a Student Internship Program Guidebook will be distributed to all SIP Coordinators/ Supervisors in all campuses of ISAT U.*
- 2. The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed upon between ISAT U and Partnered Industry who shall carry out jointly the specific projects/ undertaking. Such activities shall be subject of a separate written agreement to be signed by the duly authorized representatives of the Parties. Both Parties shall agree to carry out such activities in accordance with the laws and regulations of their respective agency's governing laws.*

IV. TERM AND VALIDITY

This Agreement shall be valid for a period of one (1) year (AY 2021-2022) to commence from the date of signing by the representatives of both Parties.

V. INTERPRETATION / DISPUTE RESOLUTION

- 1. In the event of any unforeseen incident during the existence of the collaborative activities under this Agreement, both Parties agree to negotiate a mutually acceptable solution/s. As far as practicable, these solutions shall be incorporated into the specific provisions mentioned in the Mechanics of Implementation of the separate agreement to be agreed upon separately by the Parties.*
- 2. Should any disagreement arise out of the application, interpretation or implementation of this Agreement, the Parties shall endeavor to exercise their best efforts to negotiate the differences.*

VI. AMENDMENT / MODIFICATION / TERMINATION

This Agreement may be amended or modified in writing, mutually agreed and signed by the representatives of both Parties. Either party may terminate this Agreement upon prior notice to the other in writing, at least six (6) months before the date of termination.
