RESOLUTION SUPPORTING BUENAVISTA ELEMENTARY SCHOOL AND DAPDAP NATIONAL HIGH SCHOOL FOR THE OPENING OF THE EXPANDED LIMITED FACE TO FACE CLASSES IN THE SCHOOLS DISTRICT OF TIGBAUAN FOR THE SCHOOL YEAR 2021-2022.

WHEREAS, the Public Schools District Supervisor, Mr. Edmund M. Mirasol in his letter dated March 10, 2022 requested the Municipal Mayor, Atty. Suzette T. Alquisada to help them have a resolution for the compliance of the requirements needed for the approval of the application of Buenavista Elementary School and Dapdap National High School for the opening of limited face to face classes:

WHEREAS, in a letter dated March 14, 2022 the Municipal Mayor requested this Sangguniang Bayan for the passing of a "Resolution Supporting Buenavista Elementary School and Dapdap National High School for the Opening of the Expanded Limited Face to Face Classes in this Schools District for the School Year 2021-2022;"

WHEREAS, Division Memorandum No. 038, S. 2021 was issued by Schools Division Superintendent, Roel F. Bermejo on February 24, 2022 (to Assistant Schools Division Superintendents, Division Chiefs, Public Schools District Supervisors, Heads, Public Elementary, Integrated and Secondary Schools and Other concerned) with the Subject: "Submission of Recommended Schools for the Expanded Implementation of Limited Face-to-Face Classes" preferably one (1) elementary school and one (1) secondary or integrated school to be submitted on or before February 28, 2022;

WHEREAS, a DepEd Memorandum No. 071, s. 2021 issued by DepEd Secretary, Leonor Magtolis Briones on October 15, 2021 (to Undersecretaries, Assistant Secretaries, Bureau and Service Directors, Regional Directors, School Division Superintendents, Public and Private Schools and All Other Concerned) with the Subject: "Preparation for the Pilot Face-to-Face, Expansion and Transitioning to New Normal;"

WHEREAS, President Rodrigo Roa Duterte had approved on September 20, 2021 the joint proposal of DepEd and DOH for the conduct of pilot face-to-face classes in 100 public schools and 20 private schools, or a total of 120 schools nationwide;

WHEREAS, based on the Joint Memorandum Circular No. 1, s. of 2021 signed by the Secretaries of DepEd and DOH, schools that will be included in the pilot phase must satisfy the following conditions: located in minimal risk area, secured LGU concurrence, passed the School Safety Assessment Tool (SSAT) (*enclosed to DepEd Memorandum No. 071, S. 2021*) and secured parent's consent;

WHEREAS, among the twenty one (21) elementary schools and nine (9) high schools in the Schools District of Tigbauan, Buenavista Elementary School and Dapdap National High School have complied with SSAT based on the result of the validation of Division Technical Assistance Team conducted last March 10, 2022;

WHEREAS, based on the shared responsibility indicators of the SSAT, one of the requirements is for the schools to secure support of the LGU (Barangay, Municipality, City, Province) through a resolution or a letter of support;

NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, Chairman, S.B. Committee on Education, Tourism and Civil Service and duly seconded by Hon. Dennis T. Valencia, Hon. Marlon R. Teruñez, Hon.
