Resolution No. 2022-028

RESOLUTION RECOMMENDING TO THE NEW ADMINISTRATION AND NEW SET OF SANGGUNIANG BAYAN MEMBERS TO SUSPEND THE BIDDING REQUIRED IN THE FISHERY CODE AND THE ENVIRONMENT CODE OF THE MUNICIPALITY OF TIGBAUAN, TO GIVE PRIORITY TO THE EXISTING FISHERY ZONE CONCESSIONAIRES TO ALLOW THEM TO RECOVER LOSSES BROUGHT ABOUT BY TYPHOON "ODETTE"

WHEREAS, in a letter dated February 22, 2022, the Municipal Mayor endorsed the attached appeal of fish pen owners in the Municipality of Tigbauan for the damages they incurred due to typhoon "Odette";

WHEREAS, the Municipality of Tigbauan had seven (7) existing fish corral/stationery fish nets in different fishing zones which had started its operation in the last week of November and devastated by tropical cyclone "Odette" last December 2021, thus resulted to capital loss including unemployment;

WHEREAS, to recover their losses the said operators are appealing that they be given priority to their existing fishery rights until 2022 and they are willing to pay the same bid amount;

WHEREAS, considering however, that there will be a change of LGU administration this 2022, and a new set of municipal officials will be installed into office starting July 1, 2022, this committee could not help but just recommend that "Priority" be given to the present concessionaires to allow them to recover their losses brought about by typhoon "Odette".

RESOLVED, to recommend to the New Administration and New Set Of Sangguniang Bayan Members to Suspend The Bidding Required In The Fishery Code And The Environment Code Of The Municipality Of Tigbauan, To Give Priority To The Existing Fishery Zone Concessionaires To Allow Them To Recover Losses Brought About By Typhoon “Odette”
