RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. SUZETTE T. ALQUISADA, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN THE DEED OF DONATION WITH IMELDA UY TROMPETA FOR THEIR DONATION OF FOURTEEN (14) ROADS LOTS, ONE (1) LOT FOR PARKS & PLAYGROUND, TWO (2) LOTS AS OPEN SPACE AND ONE (1) ADDITIONAL LOT AS EXCLUDED AREA, TO THE MUNICIPALITY OF TIGBAUAN

WHEREAS, a Deed of Donation, was executed by the representative of Domingo Trompeta, Jr., Imelda Uy Trompeta, as Attorney in-Fact per Special Power of Attorney document dated July 29, 2019 and acknowledged before Notary Public Igmedio S. Prado, as Doc. No. 126, Page No. 27, Book No. XXVII, series of 2019, in favor of the Municipality of Tigbauan;
