Resolution No. 2022- 039

RESOLUTION SUSPENDING THE GRANTING OF NEW FRANCHISE/ PERMIT TO OPERATE MOTORIZED TRICYCLES FOR HIRE, E-TRIKES AND PEDICABS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO PURSUANT TO MUNICIPAL ORDINANCE NO. 2020-004 SERIES OF 2020.

WHEREAS, pursuant to R.A. 7160 otherwise known as the Local Government Code of 1991, Under Article III, Section 447 (3) (vi), the Sangguniang Bayan is mandated to regulate the operation of tricycles and grant franchise for the operation thereof within the territorial jurisdiction of the municipality subject to the guidelines prescribed by the Department of Transportation and Communications;

WHEREAS, Municipal Ordinance No. 2020-004, Chapter VI, Section 12.2.7, Chapter VII Section 14.4 and Chapter VIII Section 16.6 states that the Sangguniang Bayan shall pass a resolution as to the opening or closing of the issuance of franchise or permit for tricycles, e-trike and pedicabs for hire in the Municipality of Tigbauan;

WHEREAS, the Tricycle Operators and Drivers Association (TODAs), this municipality is having an ODD-EVEN scheme/code to minimize the number of tricycles for hire plying around its territorial jurisdiction and to augment the income of drivers;

WHEREAS, in the petition letter of TODAs dated March 21, 2022 they have cited that the influx of E-trikes for hire is also one of the reasons affecting their daily income;

WHEREAS, as of March 29, 2022 our designated franchise officer has released a new/renewal franchise/permit for 778 tricycle units, 265 e-trike units and 82 pedicab units;

NOW, THEREFORE upon motion of HON. MARLON R. TERUÑEZ, *Chairman, S.B. Committee on Transportation* and duly seconded by Hon. Neri T. Camiña, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to suspend the Granting of New Franchise/Permit to Operate Motorized Tricycles For Hire, E-Trikes And Pedicabs In The Municipality Of Tigbauan, Pursuant To Municipal Ordinance No. 2020-004 Series of 2020;
