Resolution No. 2022- 040

RESOLUTION CONFORMING AND APPROVING THE CY 2022 BARANGAY ANNUAL BUDGETS OF BARANGAYS BAGUINGIN, DANAOS AND 2 POBLACION, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on April 4, 2022 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2022 Annual Budgets of Barangays Baguingin, Danaos and 2 Poblacion, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace, to wit:

The appropriation of **Brgy. Baguingin** for Annual Budget CY 2022 in the amount of **P5,615,000.00** and 20% Development Fund in the amount of **P1,109,151.80** shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.

The appropriation of **Brgy. Danaos** for Annual Budget CY 2022 in the amount of **P2,600,000.00** and 20% Development Fund in the amount of **P515,760.80** shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.

The appropriation of **Brgy. 2 Poblacion** for Annual Budget CY 2022 in the amount of **P3,172,000.00** and 20% Development Fund in the amount of **P620,918.60** shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the said Barangay Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRMF Plans and GAD Attributions which show apparent compliance with the provisions of the 1991 Local Government Code and its implementing rules and regulations;

WHEREAS, the Review of the foregoing Annual Budgets, 20% Development Plans, 10% SK Funds, 5% BDRRMF Plans and GAD Attributions of the afore-mentioned barangays likewise show apparent compliance with Section 287 of the Local Government Code, Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
