RESOLUTION SUPPORTING JAMOG INTEGRATED SCHOOL, NAPNAPAN ELEMENTARY SCHOOL, MAYOR EUGENIO TORRENTO ELEMENTARY SCHOOL, LINO FLORES ELEMENTARY SCHOOL, DAPDAP ELEMENTARY SCHOOL, LUBOG PRIMARY SCHOOL, DORONG-AN INTEGRATED SCHOOL, SIPITAN ELEMENTARY SCHOOL, PARARA NATIONAL HIGH SCHOOL, BAGACAY NATIONAL HIGH SCHOOL AND OLO-BARROC ELEMENTARY SCHOOL FOR THE OPENING OF THE PROGRESSIVE FACE TO FACE CLASSES IN THE SCHOOLS DISTRICT OF TIGBAUAN FOR THE SCHOOL YEAR 2021-2022.

WHEREAS, the Public Schools District Supervisor, Mr. Edmund M. Mirasol in his letter dated May 2, 2022 requested the Municipal Mayor, Atty. Suzette T. Alquisada for the issuance of a letter of support from her good office as well as the passing of a resolution of support from the Sangguniang Bayan;

WHEREAS, likewise in a letter dated May 2, 2022 the Municipal Mayor requested this Sangguniang Bayan for the passing of the said resolution of support;

WHEREAS, President Rodrigo Roa Duterte had approved on September 20, 2021 the joint proposal of DepEd and DOH for the conduct of pilot face-to-face classes in 100 public schools and 20 private schools, or a total of 120 schools nationwide;

WHEREAS, on October 15, 2021, DepEd Secretary, Leonor Magtolis Briones issued DepEd Memorandum No. 071, s. 2021 (*addressed to Undersecretaries, Assistant Secretaries, Bureau and Service Directors, Regional Directors, School Division Superintendents,*

Public and Private Schools and All Others Concerned) with the Subject: *“Preparation for the Pilot Face-to-Face, Expansion and Transitioning to New Normal;”*

WHEREAS, on February 24, 2022, Iloilo Schools Division Superintendent, Dr. Roel F. Bermejo issued Memorandum No. 038, S. 2021 *(to Assistant Schools Division Superintendents, Division Chiefs, Public Schools District Supervisors, Heads, Public Elementary, Integrated and Secondary Schools and Others concerned)* with the Subject: *“Submission of Recommended Schools for the Expanded Implementation of Limited Face-to-Face Classes”* preferably one (1) elementary school and one (1) secondary or integrated school to be submitted on or before February 28, 2022;

WHEREAS, on May 2, 2022, another DepEd Office Memorandum No. 152, s. 2022 was issued by DepEd Regional Director, Ramir B. Uytico EdD, CESO III *(to Dr. Roel F. Bermejo, CESO V, Schools Division Superintendent of Iloilo)* with the Subject: *“Approval of Additional Recommended Schools for the Expansion Phase of the Limited Face-to-Face Classes;”*

WHEREAS, based on the Joint Memorandum Circular No. 1, s. of 2021 signed by the Secretaries of DepEd and DOH, schools that will be included in the pilot phase must satisfy the following conditions: located in minimal risk area, secured LGU concurrence, passed the School Safety Assessment Tool (SSAT) *(enclosed to DepEd Memorandum No. 071, S. 2021)* and secured parent’s consent;

WHEREAS, one of the requirements for the schools to secure support of the LGU *(Barangay, Municipality, City, Province)* as provided in the shared responsibility indicators of the SSAT is through a resolution or a letter of support;

WHEREAS, these eleven (11) schools were pre-validated by the District Technical Assistance Team and were found compliant with the indicators set by the DepEd hence, they were recommended to the Division Office for Regional validation of the School’s readiness for the implementation of the Progressive Face-to-Face classes;

NOW, THEREFORE, on motion of HON. NERI T. CAMIÑA, Chairman, S.B. Committee on Education, Tourism and Civil Service and duly seconded by Hon. Marlon R. Teruñez, Hon. Suzette Marie Hilado-Banno, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Ma. Gerrylin Santuyo-Camposagrado, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Dyossa Marie T. Teruñez;
