WHEREAS, Hon. Marlon R. Teruñez had served Tigbauan as Member of the Sangguniang Bayan for the following terms of Office: from July 1, 2010 to June 30, 2013; from July 1, 2013 to June 30, 2016 and from July 1, 2019 to June 30, 2022;

WHEREAS, during his three (3) terms of Office as S.B. Member, Hon. Marlon R.
