RESOLUTION GIVING OUTSTANDING RECOGNITION TO HON. SUZETTE MARIE HILADO-BANNO FOR HER VALUABLE CONTRIBUTIONS AND DEDICATED SERVICE AS SANGGUNANG BAYAN MEMBER OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, through the mandate of the Tigbauanons, Honorable Suzette Marie Hilado-Banno was elected as one of the eight Sangguniang Bayan Members of this Municipality for a total of four (4) terms of Office; one (1) term *from July 1, 2007 to June 30, 2010* and three (3) consecutive terms from *July 1, 2013 to June 30, 2016; July 1, 2016 to June 30, 2019 and July 1, 2019 to June 30, 2022;*

WHEREAS, consistent with her calling as a medical practitioner and to her mandate as a public official, Hon. Banno dedicated her career in looking after the well-being of her constituents and the advancement and progress of Tigbauan;

WHEREAS, during her four (4) terms of Office as S.B. Member, Hon. Suzette Marie Hilado-Banno had rendered her valuable services to our constituents being the Chairperson and Member of various committees, the latest of which is as *Chairman of the Committee on Health & Sanitation and Committee on Women, Family, Social Services & Senior Citizens(Including Indigents);*

WHEREAS, to mention some of the significant legislations, she authored are the following:

WHEREAS, as Chairman of the S.B. Committee on Education in the year 2008, among the remarkable accomplishments of Hon. Suzette Marie Hilado-Banno (*together with Mrs. Wilma Traviña, Head Teacher III of the Bagacay Elementary School during that time*) was the creation (*through S.B. Resolution No. 2008-048*) of Bagacay High School as Secondary School Level Extension of the Tigbauan National High School Main Campus, Tigbauan, Iloilo. Hon. Banno & Mrs. Traviña were the initiators and pillars of such secondary level extension, now known as the Bagacay National High School. The High School caters students from Bagacay, Cansilayan, Supa, Bugasongan, Danao and Guisian;

WHEREAS, being dedicated, considerate and sincerely concerned on the plight of Tigbauanons especially the poor and the needy, Hon. Suzette Marie Hilado-Banno has always been known as a person of integrity, uprightness and respect;
