RESOLUTION APPROVING AND CONFORMING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2022-05, DATED MAY 5, 2022, "RESOLUTION AMENDING THE APPROVED ANNUAL INVESTMENT PROGRAM (AIP) CY 2022 SPECIFICALLY THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) FINANCIAL ASSISTANCE FROM 20% MUNICIPAL DEVELOPMENT FUND CY 2022 TO BARANGAY ATABAYAN FOR THE CONCRETING OF FARM TO MARKET ROAD (ZONE I), RE-PROGRAMMED FOR THE CONSTRUCTION OF WATER BREAKER IN THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) AND CONCRETING OF BARANGAY ROAD (ZONE I) IN THE AMOUNT OF TWO HUNDRED PESOS (250,000.00) OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Annual Investment Program for CY 2022 of the Municipality of Tigbauan, Province of Iloilo amounting to **Two Hundred Fifty-Three Million Pesos (P253,000,000.00)** was enacted by the Sangguniang Bayan through Resolution No. 2021-057, approved on May 12, 2021;

WHEREAS, the appropriation of the 20% IRA Development Fund of the Municipality of Tigbauan in the amount of **P45,965,308.80** shall be utilized to finance the LGU's priority development projects as embodied in its duly approved local development plans and Annual Investment Plan, which should be directly supportive of the Philippine Development Plan and Public Investment Program promulgated in Section 287 of R.A. 7160;

WHEREAS, out of this 20% Development Fund, P500,000.00 was allocated for the Concreting of Farm to Market Road (Zone I) of Barangay Atabayan, this Municipality and shall be re-programmed to the Construction of Water Breaker in the Amount of Two Hundred Fifty Thousand Pesos (P250,000.00) and Concreting of Barangay Road (Zone I);

WHEREAS, the perennial problem of Barangay Atabayan when typhoon comes is the storm surge that destroys fishing gears and paraphernalia of fisher folks, sand erosion and damage of properties along coastal areas and the construction of Water Breaker is one way of containing water pressure, and also the outfall of water coming from Zone I, Barangay Atabayan, Tigbauan, Iloilo;

WHEREAS, during rainy season the road in Zone I, Barangay Atabayan is very muddy and most of the time it is impassable and it is very inconvenient for the barangay constituents to pass the said area;

WHEREAS, the Municipal Development Council's participation is necessary for amending the approved Annual Investment Program (AIP) CY 2022 specifically the amount of Five Hundred Thousand Pesos (P500,000.00) *Financial Assistance from 20% Municipal Development Fund CY 2022 to Barangay Atabayan for the Concreting of Farm to Market Road (Zone I), Re-Programmed for the Construction of Water Breaker in the Amount of Two Hundred Fifty Thousand Pesos (P250,000.00) and Concreting of Barangay Road (Zone I) in the Amount of Two Hundred Pesos (250,000.00) of the Municipality of Tigbauan, Province of Iloilo;*"

WHEREAS, the Supplemental Annual Investment Plan attached to the MDC Resolution No. 2022-05 embodying the specific Plans. Programs and Activities in the amount of Five Hundred Thousand Pesos (P500,000.00) as approved by the MDC on May 25, 2022 is hereto adopted and approved and shall form as an integral part of this Resolution;

RESOLVED, to approve and conform Municipal Development Council (MDC) Resolution No. 2022-05, Dated May 5, 2022, "Resolution Amending the Approved Annual Investment Program (AIP) CY 2022 Specifically the Amount of Five Hundred Thousand Pesos (P500,000.00) Financial Assistance from 20% Municipal Development Fund CY 2022 to Barangay Atabayan for the Concreting of Farm to Market Road (Zone I), Re-Programmed for the Construction of Water Breaker in the Amount of Two Hundred Fifty Thousand Pesos (P250,000.00) and Concreting of Barangay Road (Zone I) in the Amount of Two Hundred Pesos (250,000.00) of The Municipality of Tigbauan, Province of Iloilo;
