Resolution No. 2022- 070

RESOLUTION EXPRESSING GRATEFUL APPRECIATION FOR THE EXCEPTIONAL AND OUTSTANDING SERVICE OF ATTY. VIRGILIO T. TERUEL AS VICE MAYOR OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, Vice Mayor Virgilio Teruel started his political career in 2013 when he was elected as SB Member of the Municipality of Tigbauan from July 1, 2013 to June 30, 2016;

WHEREAS, in his stint as SB Member, Vice Mayor Teruel was able to introduce and deliver numerous legislative initiatives that redounded to the benefit of Tigbauanons, making him one of the best performing SB Members;

WHEREAS, known to be a person of character and integrity, his unblemished record in public service has paved the way to his election as Vice Mayor of Tigbauan in 2016; he was also elected President of the Vice Mayor's League of the Philippines (VMLP) -Iloilo Chapter for the period 2019-2022;

WHEREAS, during his terms of office as SB Member and Vice Mayor, he exercised and displayed dedication and commitment to public service, administered and managed the Sanggunian with in-depth professionalism and efficiency earning the respect and high regard of fellow public officials and admiration of his constituents;

No. 2017-018-** “A MUNICIPAL CODE PURSUING A PUBLIC-PRIVATE PARTNERSHIP FOR THE PEOPLE INITIATIVE FOR LOCAL GOVERNMENTS (LGU P4) APPROACH TOWARDS DEVELOPMENT, PROVIDING FOR THE PROCEDURE OF SELECTING THE PRIVATE SECTOR PROPONENT, ADOPTING A CONTRACT MANAGEMENT FRAMEWORK, AND PROVIDING APPROPRIATIONS AND FOR OTHER PURPOSES;”
- **Mun. Ord. No. 2018-009-** “AN ORDINANCE PROVIDING DEATH BENEFITS AND FINANCIAL ASSISTANCE TO BARANGAY OFFICIALS OF THE MUNICIPALITY OF TIGBAUAN, ILOILO IN CASE OF DEATH OR PERMANENT TOTAL DISABILITY DURING THEIR TERM OF OFFICE, ESTABLISHING A TRUST FUND FOR THE PURPOSE, AND PRESCRIBING GUIDELINES IN THE GRANT THEREOF;”
- **Mun. Ord. No. 2020-012-** “AN ORDINANCE REGULATING THE NUMBERING OF RESIDENTIAL, COMMERCIAL, PUBLIC AND OTHER BUILDINGS IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO;”
- **Mun. Ord. No. 2020-013-** “2020 REVISED CODE OF GENERAL ORDINANCES OF THE MUNICIPALITY OF TIGBAUAN;”
- **Mun. Ord. No. 2021-004-** “AN ORDINANCE AMENDING **SECTIONS 8, 89, 91, 96, 97, 115, 116, 119 AND 156 (PENALTY CLAUSE)** AND SUPPLEMENTING/ADDING **SECTION 105 UNDER CHAPTER VIII (HEALTH AND SANITATION CODE)**, “MANDATING SOCIAL/PHYSICAL DISTANCING AND COMPULSORY WEARING OF FACE MASK AND/OR FACE SHIELD DURING THE COMMUNITY QUARANTINE PERIOD” IN THE 2020 REVISED CODE OF GENERAL ORDINANCES OF THE MUNICIPALITY OF TIGBAUAN;”

WHEREAS, last May 2022 elections, with the need and yearning of the Tigbauanons for efficient governance, and in recognition of his remarkable services, Vice Mayor Teruel was again given the full mandate by his election as Municipal Mayor of Tigbauan;
