RESOLUTION CONFORMING AND APPROVING THE CY 2022 SK ANNUAL BUDGETS OF BARANGAYS ATABAYAN, BAGUINGIN, 1 POBLACION, 8 POBLACION, BINALIUAN MENOR, BUENAVISTA, DAPDAP, DORONG-AN, GUISIAN, NAMOCON AND SAN RAFAEL, THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on June 15, 2022 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2022 SK Annual Budgets of Barangay Atabayán, Baguingin, 1 Poblacion, 8 Poblacion, Binaliuan Menor, Buenavista, Dapdap, Dorong-an, Guisian, Namocón and San Rafael, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace, to wit:

*The appropriation of **Brgy. Atabayán** for the SK Annual Budget CY 2022 in the amount of **P500,000.00** to be utilized for General Administrative Program in the amount of P162,000.00 and SK Development Empowerment Program in the amount of P338,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Baguingin** for the SK Annual Budget CY 2022 in the amount of **P561,500.00** to be utilized for General Administrative Program in the amount of P206,500.00 and SK Development Empowerment Program in the amount of P355,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. 1 Poblacion** for the SK Annual Budget CY 2022 in the amount of **P318,000.00** to be utilized for General Administrative Program in the amount of P98,000.00 and SK Development Empowerment Program in the amount of P220,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. 8 Poblacion** for the SK Annual Budget CY 2022 in the amount of **P355,000.00** to be utilized for General Administrative Program in the amount of P90,000.00 and SK Development Empowerment Program in the amount of P265,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Binaliuan Menor** for the SK Annual Budget CY 2022 in the amount of **P280,500.00** to be utilized for General Administrative Program in the amount of P141,500.00 and SK Development Empowerment Program in the amount of P139,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Buenavista** for the SK Annual Budget CY 2022 in the amount of **P268,000.00** to be utilized for General Administrative Program in the amount of P93,000.00 and SK Development Empowerment Program in the amount of P175,000.00 of the aforementioned barangay.*

The appropriation of **Brgy. Dapdap** for the SK Annual Budget CY 2022 in the amount of **P273,000.00** to be utilized for General Administrative Program in the amount of P98,000.00 and SK Development Empowerment Program in the amount of P175,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Dorong-an** for the SK Annual Budget CY 2022 in the amount of **P486,000.00** to be utilized for General Administrative Program in the amount of P144,500.00 and SK Development Empowerment Program in the amount of P341,500.00 of the aforementioned barangay.

The appropriation of **Brgy. Guisian** for the SK Annual Budget CY 2022 in the amount of **P228,000.00** to be utilized for General Administrative Program in the amount of P113,000.00 and SK Development Empowerment Program in the amount of P115,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Namocon** for the SK Annual Budget CY 2022 in the amount of **P467,000.00** to be utilized for General Administrative Program in the amount of P102,000.00 and SK Development Empowerment Program in the amount of P365,000.00 of the aforementioned barangay.

The appropriation of **Brgy. San Rafael** for the SK Annual Budget CY 2022 in the amount of **P234,000.00** to be utilized for General Administrative Program in the amount of P84,500.00 and SK Development Empowerment Program in the amount of P150,000.00 of the aforementioned barangay.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned SK Annual Budgets which shows apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
