RESOLUTION GRANTING OMNIBUS AUTHORITY TO THE MUNICIPAL MAYOR, ATTY. VIRGILIO T. TERUEL, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT-REGIONAL OFFICE VI (DOLE-RO6) FOR THE IMPLEMENTATION OF GOVERNMENT INTERNSHIP PROGRAM (DOLE-GIP), TULONG PANGHANAPBUHAY SA ATING DISADVANTAGED/DISPLACED WORKERS (DOLE-TUPAD), SPECIAL PROGRAM FOR EMPLOYMENT OF STUDENTS (DOLE-SPES), CASH-FOR-WORK PROGRAM, AND DOLE INTEGRATED LIVELIHOOD PROGRAM (DILP) OR "KABUHAYAN PROGRAM" IN THE LOCAL GOVERNMENT UNIT OF TIGBAUAN.

WHEREAS, Section 444 (a), (b), (vi) of the Local Government Code provides among others, to wit:

SEC. 444. The Chief Executive: Powers, Duties, Functions and Compensation. - (a) The Municipal Mayor, as the chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

x x x

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Department of Labor and Employment – Regional Office VI has appropriated funds under its 2022 Annual Budget for the implementation of Government Internship Program (DOLE-GIP), Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (DOLE-TUPAD), Special Program for Employment of Students (DOLE-SPES), Cash-for-Work Program, and DOLE Integrated Livelihood Program (DILP) or “Kabuhayan Program” in the Province of Iloilo;

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to engage GIP interns in public service by involving them in government programs, projects and services, through the various GIP Partner Agencies;

WHEREAS, the DOLE provides program for the poor/indigent beneficiaries, opportunity to demonstrate their talents and skills in the field of public service with the ultimate objective of attaining the best and brightest who want to pursue a career in government service, particularly in the fields and disciplines related to labor and employment;

WHEREAS, TUPAD or Tulong Panghanap buhay sa Ating Disadvantaged/Displaced Workers is a community-based package of assistance that provides emergency employment for displaced workers, underemployed and seasonal workers, for a minimum period of 10 days, but not to exceed a maximum of 30 days, depending on the nature of work to be performed;

WHEREAS, Special Program for the Employment of Students (SPES) is DOLE’s youth employment-bridging program which aims to provide temporary employment to poor but deserving students, out-of-school youth, and dependents of displaced or would-be displaced workers during summer and/or Christmas vacation or any time of the year to augment the family’s income to help ensure that beneficiaries are able to pursue their education;

WHEREAS, DOLE Integrated Livelihood Program (DLIP) or KABUHAYAN is a grant assistance for capacity-building on livelihood for the working poor, vulnerable and marginalized workers, either for individual or group livelihood projects/undertakings;

WHEREAS, the Local Government Unit (LGU) of Tigbauan has requested funds/financial assistance for implementation of various projects from DOLE-RO6;

WHEREAS, there is a need for execution of Memorandum of Agreement in order to release/transfer the said funds to the Municipality of Tigbauan;

WHEREAS, through this undertaking, the fast and efficient delivery of services will be ensured and will definitely inure to the benefit and general welfare of the people of Tigbauan;

WHEREAS, to assure full transparency and accountability, the Local Chief Executive shall periodically update the local Sanggunian of the projects and programs that LGU Tigbauan undertakes in partnership with the Department of Labor and Employment, Region VI (DOLE-RO6);

NOW, THEREFORE, on motion of HON. ADRIAN CAMPOSAGRADO, Vice Chairman, Committee on Economic Affairs, Investment, Labor and Employment (*under the sponsorship of Hon. Vice Mayor Lugen T. Ortilano, Committee Chairman,*) and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba and Hon. Dyossa Marie T. Terunez,

Teruel, for and in Behalf of the Municipality of Tigbauan To Enter Into A Memorandum of Agreement (MOA) With the Department Of Labor and Employment-Regional Office VI (DOLE-RO6) for the Implementation of Government Internship Program (DOLE-GIP), Tulong Panghanapbuhay sa Ating Disadvantaged/Displaced Workers (DOLE-TUPAD), Special Program for Employment of

Students (DOLE-SPES), Cash-For-Work Program, and Dole Integrated Livelihood Program (DILP) or “Kabuhayan Program” in the Local Government Unit of Tigbauan;
