RESOLUTION AMENDING RULE VII, SECTION 14(a) OF RESOLUTION NO. 2022-077 OTHERWISE KNOWN AS THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF TIGBAUAN, ILOILO, BY TRANSFERRING THE REGULAR SESSION DAY FROM "...*EVERY MONDAY, 9:30 IN THE MORNING.*" TO "...**EVERY WEDNESDAY AT 9:00 O'CLOCK IN THE MORNING**".

WHEREAS, Rule VII, Section 14 of Resolution No. 2022-077 provides:

***"RULE VII – REGULAR AND SPECIAL SESSIONS***

***Section 1. REGULAR SESSION***

- (a) The minimum number of regular sessions of the Sanggunian shall be "once a week".*
- (b) The regular session shall be held every Monday and shall start promptly at 9:30 in the morning. Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.*
- (c) The sanggunian shall as far as practicable adopt a paperless session policy.*

WHEREAS, for purposes of convenience and efficiency of the delivery of basic services there is a need to transfer the session day to accommodate more clients and to facilitate promptness of the legislative action;

WHEREAS, the members of this August Body in its Regular Session dated July 11, 2022, decided on consensus to amend Rule VII-Section 14(a) of S.B.s Internal Rules of Procedure by transferring the schedule of regular session day from Monday at 9:30 in the morning to **Wednesday at 9:00 o'clock in the morning**;


NOW, THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Chairman, Committee on Rules, Ordinances, Resolutions and Legal Matters and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Ana Rowena A. Perera, Hon. Maribeth L. Tupino and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to amend RULE VII, SECTION 14(a) of Resolution No. 2022-077 otherwise known as the Internal Rules of Procedure of the Sangguniang Bayan of Tigbauan, Iloilo, by Transferring the Regular Session Day from "...every Monday, 9:30 in the morning." to **"every Wednesday at 9:00 o'clock in the morning"**;
