RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN THE APPLICATION OF SPECIAL PATENT FROM COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) COVERING LOT NO. 218 WITH AN AREA OF 0.0506 HECTARES LOCATED AT TUPAS-TUPAN STS., BARANGAY 5 (POB.), TIGBAUAN, ILOILO

WHEREAS, a Certification was issued by Ms. Elma G. Tionsay, Municipal Treasurer on July 13, 2022, stating that Lot Number 218 with an area of 0.506 hectares is located at Tupas-Tupan Sts., Brgy. 5 (Pob.), Tigbauan, Iloilo under Tax Declaration No. 40-005-0025 in the name of Municipal Government of Tigbauan as its declared owner;

WHEREAS, said lot had been leased by Santos Petroleum Corporation for ten (10) years (2010-2020) but since the location is not suitable for a gas station, the LGU-Tigbauan deems it proper to disallow the request of Santos Petroleum to renew its Lease Contract;

WHEREAS, since the abovementioned lot is now open for lease, the Municipal Government of Tigbauan is now inviting stakeholders/financiers to invest and do business in our town through said lot. However since it is still an untitled lot and one of the lease requirements is for the property to be titled, the Municipal Mayor decided to fast track compliance of all the needed documents, particularly this Special Patent Application to the Community Environment and Natural Resources Office (CENRO);

Teruel, Municipal Mayor, in Behalf of the Municipality of Tigbauan to Sign the Application of Special Patent from Community Environment and Natural Resources Office (CENRO) Covering Lot No. 218 With an Area of 0.0506 Hectares Located at Tupas-Tupan Sts., Barangay 5 (Pob.), Tigbauan, Iloilo;
