**Resolution No. 2022-087**

RESOLUTION AUTHORIZING ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN THE SPECIAL POWER OF ATTORNEY (SPA) IN FAVOR OF TAMMY MARIE R. ESMERALDA TO PROCESS THE REQUIREMENTS FOR THE APPLICATION OF SPECIAL PATENT OF THE MUNICIPALITY OF TIGBAUAN, ILOILO.

WHEREAS the Local Government Unit of Tigbauan applied for a Special Patent for Lot 218 with an area of 0.506 hectares located at Tupas-Tupan Sts., Poblacion, Brgy. 5, Tigbauan, Iloilo with Tax Declaration No. 40-005-0025 under the name of Municipal Government of Tigbauan as its declared owner;

WHEREAS, Section 444 (vi) of the Local Government Code provides that *"the Chief Executive shall, upon authorization by the Sangguniang Bayan represent the municipality in all its business transactions and sign on its behalf all contracts and obligations, and such other documents made pursuant to law or ordinance"*, but she may delegate some ministerial duties to some other persons upon proper authorization;

WHEREAS, Tammy Marie R. Esmeralda is hereby authorized to process the titling of Lot 218 under the name of Municipal Government of Tigbauan;
