RESOLUTION CALLING ON ALL COMMUNITY BASED ORGANIZATIONS, PEOPLE'S ORGANIZATIONS, CIVIL SOCIETY ORGANIZATIONS, COOPERATIVES, NON-GOVERNMENT ORGANIZATIONS AS WELL AS BUSINESS AND PROFESSIONAL GROUPS AND OTHER SIMILAR AGGRUPATIONS WHETHER PREVIOUSLY ACCREDITED OR SEEKING ACCREDITATION FOR THE FIRST TIME TO APPLY FOR ACCREDITATION FOR MEMBERSHIP IN THE LOCAL SPECIAL BODIES OF THE MUNICIPALITY.

WHEREAS, Article 62, Rule XIII of the Implementing Rules and Regulations of the Local Government Code of 1991 (Republic Act No. 7160) mandates local government units to promote meaningful participations of Community Based Organizations, Civil Society Organizations, Cooperatives, Non-Government Organizations, People's Organizations and the Private Sectors to make them active partners in the pursuit of local autonomy and furtherance of development;

WHEREAS, in the pursuit of excellence in local public administration, it is important to develop and strengthen this partnership in order to empower citizens to actively participate in the decision-making process, program planning, implementation, monitoring and evaluation in the local level which can help increase the efficiency of delivering services in the locality;

WHEREAS, the Code institutionalizes this participation through membership in the Local Special Bodies which are primarily created and organized as the advisory and recommendatory bodies of the Local Government Units;

BE IT RESOLVED, to call on All Community Based Organizations, People's Organizations, Civil Society Organizations, Cooperatives, Non-Government Organizations As Well As Business And Professional Groups And Other Similar Aggrupations Whether Previously Accredited Or Seeking Accreditation For The First Time To Apply For Accreditation For Membership In The Local Special Bodies Of The Municipality,
