RESOLUTION SUPPORTING ST. THERESE-MTC COLLEGES-TIGBAUAN TO REOPEN CAMPUS FOR THE CONDUCT OF LIMITED FACE TO FACE CLASSES FOR BACHELOR OF SCIENCE IN MARINE TRANSPORTATION AND BACHELOR OF SCIENCE IN MARINE ENGINEERING FOR THE ACADEMIC YEAR 2022-2023

WHEREAS, the St. Therese-MTC Colleges President, Dr. Ma. Teresa S. Sarabia, in her letter dated June 29, 2022, seeks permission from the Municipal Mayor, Atty. Virgilio T. Teruel, to be allowed to conduct 100% face to face classes on the academic year 2022-2023;

WHEREAS, likewise in a letter dated August 1, 2022 the Municipal Mayor requested this Sangguniang Bayan for the urgent passing of a resolution of support related to this subject;

WHEREAS, the Commission on Higher Education Regional Office VI – Western Visayas has issued a Certificate of Authority to St. Therese-MTC Colleges-Tigbauan to reopen campus for the conduct of Limited Face-to-Face Classes for Bachelor of Science in Marine Transportation and Bachelor of Science in Marine Engineering after having complied with the requirements of the Commission on Higher Education and Department of Health, under Joint Memorandum Circular and CMOs, effective July 11, 2022-July 10, 2023;

WHEREAS, this authority shall be subject to revocation if the institution fails to maintain and to comply with the rules and regulations as stated in the said Joint Memorandum Circular pertaining to limited face-to-face classes.
