RESOLUTION INTERPOSING NO OBJECTION FOR THE FREE PATENT APPLICATION OF BARANGAYBAGUINGIN SETTLEMENT AREA COVERING AN AREA OF 6,030 SQUARE METERS

WHEREAS, in a letter dated August 2, 2022, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of a “Resolution Interposing No Objection For The Free Patent Application Of BarangayBaguingin Settlement Area Covering An Area Of 6,030 Sq. M.”;

WHEREAS, the “HandogTitulo” Program of the Department of Environment and Natural Resources (DENR) was formulated to accelerate the issuance of public land patents to qualified recipients in order to alleviate poverty and contribute to progress and development of the country;

WHEREAS, in a letter dated May 23, 2022 of Vicente T. Mellizas, Jr., CENR Officer, DENR-CENRO, Miag-ao, Iloilo, CENRO, Guimbal, said office confirmed receipt of a public land application under the applicant name, JENERA R. TROFEO, ET. AL;

WHEREAS, during the pre-session conference of the Honorable Sangguniang Bayan of Tigbauan, as per the urgent letter of the Municipal Mayor dated June 15, 2022, Mr. Edgardo Ferrer, Chief Investigator of the Community Environment and Natural Resources Office (CENRO) together with MENRO Designate, Mr. Rexfel G. Trivilegio, Mrs. Tammy Marie Esmeralda from the Municipal Assessor’s Office and Punong Barangay Nixon Torrato of Barangay Baguingin, Tigbauan, Iloilo, appeared before the Sangguniang Bayan Members to answer queries regarding the request for a Certificate of No Objection for the Residential Free Patent Application of JENERA R. TROFEO, ET. AL. of Sitio Sinikway, Barangay Baguingin, Tigbauan, Iloilo;
