RESOLUTION CONFIRMING AND APPROVING THE **A.) CY 2022 ANNUAL BUDGET OF BARANGAY BUGASONGAN B.) CY 2022 SUPPLEMENTAL BUDGET OF BARANGAY ATABAYAN C.) CY 2022 SK ANNUAL BUDGETS OF BARANGAYS BAGUMBAYAN, BITAS, CORDOVA NORTE, JAMOG, BAGACAY, 7 POBLACION, BINALIUAN MAYOR, CORDOVA SUR, NAPNAPAN NORTE, OLO BARROC, SIPITAN, TAN PAEL, ALUPIDIAN, BANTUD, NAPNAPAN SUR AND PARARA NORTE, THIS MUNICIPALITY.**

WHEREAS, the Municipal Budget Officer on July 11, 2022, July 15, 2022 and July 26, respectively endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the a.) CY 2022 Annual Budget of Barangay Bugasongan b.) CY 2022 Supplemental Budget of Barangay Atabayán c.) CY 2022 SK Budgets of Barangays Bagumbayan, Bitas, Cordova Norte, Jamog, Bagacay, 7 Poblacion, Binaliuan Mayor, Cordova Sur, Napnapan Norte, Olo Barroc, Sipitan, Tan Pael, Alupidian, Bantud, Napnapan Sur and Parara Norte this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2022 Annual Budget of Barangay Bugasongan, to wit:

*The appropriation of Brgy. Bugasongan for Annual Budget CY 2022 in the amount of **P2,210,000.00** and 20% Development Fund in the amount of **P438,978.80** shall be utilized for projects incidental to the efficient and effective provisions of basic services to the populace.*

b.) CY 2022 Supplemental Budgets of barangays Atabayán to wit:

*The appropriation of Brgy. Atabayán for Supplemental Budget No. 2022-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P407,400.27** is for the **Procurement of Solar Street lights, concreting of footwalk, Brace Support Louver at the Evacuation Center, Laptop and Printer, CCTV and Session Tables** chargeable against CY 2020 & 2021—Revenue and Retained Operating Surplus (PS & MOOE)-407,400.27 of the aforementioned barangay.*

c.) CY 2022 SK Annual Budgets of the following Barangays to wit:

The appropriation of **Brgy. Bagumbayan** for the SK Annual Budget CY 2022 in the amount of **P423,000.00** to be utilized for General Administrative Program in the amount of P96,000.00 and SK Development Empowerment Program in the amount of P327,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Bitas** for the SK Annual Budget CY 2022 in the amount of **P430,000.00** to be utilized for General Administrative Program in the amount of P163,000.00 and SK Development Empowerment Program in the amount of P267,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Cordova Norte** for the SK Annual Budget CY 2022 in the amount of **P384,500.00** to be utilized for General Administrative Program in the amount of P112,000.00 and SK Development Empowerment Program in the amount of P272,500.00 of the aforementioned barangay.

The appropriation of **Brgy. Jamog** for the SK Annual Budget CY 2022 in the amount of **P279,000.00** to be utilized for General Administrative Program in the amount of P129,000.00 and SK Development Empowerment Program in the amount of P150,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Bagacay** for the SK Annual Budget CY 2022 in the amount of **P389,000.00** to be utilized for General Administrative Program in the amount of P249,000.00 and SK Development Empowerment Program in the amount of P140,000.00 of the aforementioned barangay.

The appropriation of **Brgy. 7 Poblacion** for the SK Annual Budget CY 2022 in the amount of **P337,000.00** to be utilized for General Administrative Program in the amount of P92,000.00 and SK Development Empowerment Program in the amount of P245,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Binaliuan Mayor** for the SK Annual Budget CY 2022 in the amount of **P345,000.00** to be utilized for General Administrative Program in the amount of P95,000.00 and SK Development Empowerment Program in the amount of P250,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Cordova Sur** for the SK Annual Budget CY 2022 in the amount of **P381,500.00** to be utilized for General Administrative Program in the amount of P166,500.00 and SK Development Empowerment Program in the amount of P215,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Napnapan Norte** for the SK Annual Budget CY 2022 in the amount of **P440,000.00** to be utilized for General Administrative Program in the amount of P90,000.00 and SK Development Empowerment Program in the amount of P350,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Olo Barroc** for the SK Annual Budget CY 2022 in the amount of **P244,500** to be utilized for General Administrative Program in the amount of P99,500.00 and SK Development Empowerment Program in the amount of P145,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Sipitan** for the SK Annual Budget CY 2022 in the amount of **P255,000.00** to be utilized for General Administrative Program in the amount of P85,000.00 and SK Development Empowerment Program in the amount of P175,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Tan Pael** for the SK Annual Budget CY 2022 in the amount of **P354,000.00** to be utilized for General Administrative Program in the amount of P129,000.00 and SK Development Empowerment Program in the amount of P225,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Alupidian** for the SK Annual Budget CY 2022 in the amount of **P235,500.00** to be utilized for General Administrative Program in the amount of P105,500.00 and SK Development Empowerment Program in the amount of 130,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Bantud** for the SK Annual Budget CY 2022 in the amount of **P243,600.00** to be utilized for General Administrative Program in the amount of P103,600.00 and SK Development Empowerment Program in the amount of P140,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Napnapan Sur** for the SK Annual Budget CY 2022 in the amount of **P385,000.00** to be utilized for General Administrative Program in the amount of P96,000.00 and SK Development Empowerment Program in the amount of P289,000.00 of the aforementioned barangay.

The appropriation of **Brgy. Parara Norte** for the SK Annual Budget CY 2022 in the amount of **P456,000.00** to be utilized for General Administrative Program in the amount of P146,000.00 and SK Development Empowerment Program in the amount of P310,000.00 of the aforementioned barangay.

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Barangay Annual Budget, SK Annual Budgets and Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
