RESOLUTION CONFORMING AND APPROVING THE **A.)** CY 2022 SUPPLEMENTAL BUDGET OF BARANGAY BITAS **B.)** CY 2022 SK ANNUAL BUDGETS OF BARANGAYS BANGKAL, 2 POBLACION, BAROSONG, CANABUAN, LINOBAYAN, LUBOG, PARARA SUR, SERMON AND TARO THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on August 3, 2022 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the a.) CY 2022 Supplemental Budget of Barangay Bitas b.) CY 2022 SK Budgets of Barangays: Bangkal, 2 Poblacion, Barosong, Canabuan, Linobayan, Lubog, Parara Sur, Sermon and Taro this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

a.) CY 2022 Supplemental Budgets of barangay Bitas to wit:

*The appropriation of Brgy. Bitas for Supplemental Budget No. 2022-01 embodying Appropriation Ordinance No. 2021-01 in the amount of **P600,000.00** is for the **Continuing Construction of Multi-Purpose Gym** chargeable against CY 2019-Retained Operating Surplus (PS % MOOE)-276,477.27, CY 2019 – Savings from 20% Development Fund (Reprogramming of 20% Development Fund Projects) – 132,470.30, CY 2020—Retained Operating Surplus (PS & MOOE) – 161,714.67 and CY 2021 Retained Operating Surplus (PS & MOOE) - 29,337.76 of the aforementioned barangay.*

b.) CY 2022 SK Annual Budgets of the following Barangays to wit:

*The appropriation of Brgy. Bangkal for the SK Annual Budget CY 2022 in the amount of **P300,000.00** to be utilized for General Administrative Program in the amount of P85,000.00 and SK Development Empowerment Program in the amount of P215,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. 2 Poblacion** for the SK Annual Budget CY 2022 in the amount of **P317,200.00** to be utilized for General Administrative Program in the amount of P112,200.00 and SK Development Empowerment Program in the amount of P205,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Barosong** for the SK Annual Budget CY 2022 in the amount of **P343,000.00** to be utilized for General Administrative Program in the amount of P93,000.00 and SK Development Empowerment Program in the amount of P250,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Canabuan** for the SK Annual Budget CY 2022 in the amount of **P263,200.00** to be utilized for General Administrative Program in the amount of P98,200.00 and SK Development Empowerment Program in the amount of P165,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Linobayan** for the SK Annual Budget CY 2022 in the amount of **P250,000.00** to be utilized for General Administrative Program in the amount of P120,000.00 and SK Development Empowerment Program in the amount of P130,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Lubog** for the SK Annual Budget CY 2022 in the amount of **P252,500.00** to be utilized for General Administrative Program in the amount of P97,500.00 and SK Development Empowerment Program in the amount of P155,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Parara Sur** for the SK Annual Budget CY 2022 in the amount of **P490,000.00** to be utilized for General Administrative Program in the amount of P265,000.00 and SK Development Empowerment Program in the amount of P225,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Sermon** for the SK Annual Budget CY 2022 in the amount of **P226,500.00** to be utilized for General Administrative Program in the amount of P76,500.00 and SK Development Empowerment Program in the amount of P150,000.00 of the aforementioned barangay.*

*The appropriation of **Brgy. Taro** for the SK Annual Budget CY 2022 in the amount of **P240,000.00** to be utilized for General Administrative Program in the amount of P79,500.00 and SK Development Empowerment Program in the amount of P161,000.00 of the aforementioned barangay.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned SK Annual Budgets and Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;
