Resolution No. 2022-101

A RESOLUTION LIFTING THE SUSPENSION ON THE ISSUANCE OF NEW PERMITS FOR ELECTRIC TRICYCLES OR ALSO KNOWN AS E-TRIKES IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, on March 30, 2022, through Sangguniang Bayan Resolution No. 2022-039, the issuance of new permits for Electric Tricycles or also known as E-Trikes was suspended;

WHEREAS, the moratorium on the issuance of new permits was implemented due to the raising concerns on the increasing number of E-Trikes in the poblacion;

WHEREAS, during a meeting with E-trike Operators dated August 5, 2022, the body approved to lift the suspension on the issuance of new permits under a set of agreements;

NOW THEREFORE, on motion of HON. NORBERTO T. TURALBA, Chairman, Committee On Transportation and duly seconded by Hon. Adrian S. Camposagrado, Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Ana Rowena A. Perera, Hon. Maribeth L. Tupino and Hon. Dyossa Marie Teruñez;

BE IT RESOLVED, as it is hereby RESOLVED that the issuance of new permits for Electric Tricycles or also known as E-Trike be lifted immediately on August 18, 2022;

RESOLVED FURTHER, that the number of new permits allowed to be issued is only one hundred thirty-three (133);

RESOLVED FURTHER, that a moratorium shall take effect once the total number of permitted E-Trikes in the Municipality of Tigbauan reach the number of four hundred (400);

RESOLVED FURTHER, that the Registration Fee and Other Fees for New Permits for E-Trike as set by the Traffic Code of the Municipality of Tigbauan shall be strictly implemented;
