A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. VIRGILIO T. TERUEL, TO HIRE TWO (2) LEARNING SUPPORT AIDS FOR JAMOG INTEGRATED SCHOOL, AND TWO (2) LEARNING SUPPORT AIDS FOR DORONG-AN INTEGRATED SCHOOL FROM AUGUST 22, 2022 TO DECEMBER 31, 2022

WHEREAS, the Local School Board (LSB) is a special body created by virtue of Republic Act No. 7160, popularly known as the Local Government Code of 1991;

WHEREAS, the LSB’s main duty is to allocate the Special Education Fund (SEF) to meet the supplementary needs of the local public school system;

WHEREAS, an amount of One Hundred Thousand Pesos (P100,000.00) from the “Sports and Cultural Development Program” was reprogrammed to the “Honorarium of Learning Support Aids” to cover the expenses for urgent need of hiring a total of four (4) Learning Support Aids.
