RESOLUTION CONFORMING AND ADOPTING LOCAL SCHOOL BOARD RESOLUTION, RESOLUTION REPROGRAMMING THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (₱100,000.00) FROM THE SPORTS AND CULTURAL DEVELOPMENT PROGRAM OF THE SPECIAL EDUCATION FUND TO THE HONORARIUM OF LEARNING SUPPORT AIDS

WHEREAS, the Local School Board (LSB) is a special body created by virtue of Republic Act No. 7160, popularly known as the Local Government Code of 1991;

WHEREAS, the LSB’s main duty is to allocate the Special Education Fund (SEF) to meet the supplementary needs of the local public school system;

WHEREAS, during a special meeting of the Local School Board of the Municipality of Tigbauan, dated August 15, 2022 at the Sangguniang Bayan Session Hall of Tigbauan, the reprogramming of a part of the allocated budget for “Sports and Cultural Development Program” of the approved Expenditures of 2022 was approved;

WHEREAS, through an approved resolution, an amount of One Hundred Thousand Pesos (P100,000.00) from the “Sports and Cultural Development Program” was reprogrammed to the “Honorarium of Learning Support Aids;”

WHEREAS, this amount will cover the necessary financial requirements for hiring a total of four (4) Learning Support Aids, two of which shall be assigned in Dorong-an Integrated School and other two shall be assigned in Jamog Integrated School;
