RESOLUTION GRANTING OMNIBUS AUTHORITY TO HONORABLE MAYOR ATTY. VIRGILIO T. TERUEL, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO PROVINCIAL GOVERNMENT FOR THE TRANSFER OF FUNDS/GRANT OF FINANCIAL ASSISTANCE FOR THE PROJECTS COVERING THE PERIOD, JULY 1, 2022 UNTIL JUNE 30, 2025

WHEREAS, the Iloilo Provincial Government has appropriated funds under its regular Annual Budget for the implementation of infrastructure and socio-cultural projects of the different municipalities in the Province of Iloilo;

WHEREAS, the Local Government Unit (LGU) of Tigbauan has requested funds/financial assistance for the implementation of its various projects from the Iloilo Provincial Government;

WHEREAS, there is a need to authorize the Municipal Mayor, Atty. Virgilio T. Teruel, to enter into a Memorandum of Agreement with the Iloilo Provincial Government in order that LGU Tigbauan could immediately effect the release/transfer of funds for its various municipal projects;

WHEREAS, Section 444 (a), (b), (vi) of the Local Government Code provides among others, to wit:

SEC. 444. The Chief Executive: Powers, Duties, Functions and Compensation. - (a) The Municipal Mayor, as the chief executive of the municipal government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws.

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code, the municipal mayor shall:

(vi) Upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, this omnibus authority to the Municipal Mayor covers the period, July 1, 2022 until the expiration of the current term of office of Mayor Atty. Virgilio T. Teruel on June 30, 2025;

WHEREAS, through this grant of authority, the fast and efficient delivery of services will be ensured for the benefit and general welfare of the people of Tigbauan;

WHEREAS, to assure full transparency and accountability, the Local Chief Executive shall periodically update the local Sanggunian of the projects and programs that LGU-Tigbauan undertakes in partnership with the Iloilo Provincial Government;

NOW, THEREFORE, on motion of HON. JULIUS T. LEDESMA, Chairman, Committee on Appropriations, Budget, Finance and Accounts and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson and Hon. Ana Rowena A. Perera;

BE IT RESOLVED, to grant Omnibus Authority to Honorable Atty. Virgilio T. Teruel for and in behalf of the Municipality of Tigbauan to Sign and Enter Into A Memorandum of Agreement (MOA) with the Iloilo Provincial Government for the Transfer of Funds/Grant of Financial Assistance for the projects covering the period, July 1, 2022 until June 30, 2025,

RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the Provincial Government, Iloilo City, to Hon. Atty. Virgilio T. Teruel, Municipal Mayor, this municipality and all concerned for their information and/or appropriate action.
