RESOLUTION AUTHORIZING ATTY. VIRGLIO T. TERUEL, MUNICIPAL MAYOR IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH CENTRAL PHILIPPINE UNIVERSITY (CPU) TO COLLABORATE ON SOCIAL DEVELOPMENT PROGRAMS AND OTHER NECESSARY SUPPORT AND COOPERATION FOR THE GOOD OF THE CONSTITUENTS.

WHEREAS, Tigbauan, through its Municipal Mayor, Atty. Virgilio T. Teruel, requested assistance from the Central Philippine University to ensure the sustainability and competitiveness of MSME's and Tourism in the Municipality through Social Development Programs;

WHEREAS, the Local Chief Executive in a letter dated August 22, 2022, requested this Sangguniang Bayan for the URGENT passing of a "Resolution Authorizing Atty. Virglio T. Teruel, Municipal Mayor in Behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement (MOA) With Central Philippine University (CPU) to Collaborate on Social Development Programs and Other Necessary Support and Cooperation for the Good of the Constituents;"

WHEREAS, the said Memorandum of Agreement shall be made and entered into by, and between the CENTRAL PHILIPPINE UNIVERSITY, a non- profit, non-stock institution of learning, created and organized in accordance with the law, represented by its president, DR. TEODORO C. ROBLES, referred to as "CPU" and the MUNICIPALITY OF TIGBAUAN,

WHEREAS, the said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- The CENTRAL PHILIPPINE UNIVERSITY, a non- profit, non-stock institution of learning, created and organized in accordance with the law, with principal office located at Lopez Jaena Street, Jaro, Iloilo City, herein after referred to as "CPU, represented by its president, DR. TEODORO C. ROBLES,
- The MUNICIPALITY **OF TIGBAUAN**, a local government unit in the Province of Iloilo with principal office address at Tejero St., Tigbauan, Iloilo, herein after referred to as "TIGBAUAN" represented by its Local Chief Executive, ATTY. VIRGILIO T. TERUEL,;"

WHEREAS, the Central Philippine University envisions "A University committed to Exemplary Christian Education For life (EXCEL) and responsive to the needs of the total person and the world;"

WHEREAS, CPU established the University Outreach Center as a service arm to implement social development programs that help improve the life of our people with the following Objectives:

- 1.) Faculty, staff, and students are actively involved in the outreach programs and community services of the community;
- 2.) Each college/unit will have an integrated functional outreach program and with one additional partner community every two years;
- 3.) Establish linkages with national government agencies (NGAs), local government units (LGUs), non-government organizations (NGOs) and people's organizations (POs);
- 4.) Regular monitoring and evaluation of programs and services implemented in existing and new partner communities;
- 5.) Partner communities and serving other communities.

WHEREAS, CPU has been engaged in various programs and services to reach its goals:

WHEREAS, the College of Hospitality Management has initiated periodic outreach activities in the Municipality of Tigbauan for many years, although these were not consolidated;

WHEREAS, in consideration of the foregoing premises and of the covenants set forth, the parties have agreed on the terms and references and working relationships, as follows:

PROJECT OBJECTIVES:

- 1. To provide opportunities/experiences for students, faculty and staff to apply theories learned in school to promote social consciousness and community involvement.
- 2. To jointly harness the resources of the university and the municipality to assist in the identification, prioritization and formulation of plan of action and its consequent implementation to solve the needs and problems of the municipality.
- 3. To promote and maintain harmonious relationship between the university and community in which one learns from the other, and
- 4. To ensure measures to evaluate the impact of the program.

ROLE OF THE COOPERATING PARTIES:

A. Role of CPU through the College of Hospitality Management:

- 1. Assign students/ faculty/ staff to do community studies, community organization, civic welfare, literacy other services and community work.
- 2. Make available the resources of the University when necessary such as resource persons, student's involvement/ participation and other community work.
- 3. Provide available services of the university within the expertise of its different colleges/ units as embodies in the aforementioned programs and services

4. Facilitate/ coordination activities to link up the needs of the community to the resources available from various organizations are it governmental or NGOs.

B. ROLE OF THE MUNICIPALITY

- 1. Ensure the safety and security of students, faculty and staff assigned in the barangay for integration, exposure, practicum, and regular work.
- 2. Provide an office/ place where the aforementioned CPU constituents can stay within the available period of the partnership.
- 3. Make available the resources of the barangay (both human and material resources) when necessary for the implementation of community projects.
- Provide necessary support including the aid of legislation and other mandated authority of the barangay council when the need arises for the approval and implementation of the project.

EFFECTIVITY

This agreement shall take effect upon approval of the parties herein for a period of 2 years and/or may be renewed, revoked, on valid grounds/ reasons, by the parties upon thirty (30) days' notice.

AMENDMENT

The Parties, hereto may, upon consent, amend or modify this Agreement by or through an addendum signed by the two parties.

NOW, THEREFORE, on motion of HON. ANA ROWENA A. PERERA, Vice Chairperson, Committee on Education, Tourism & Civil Service (under the sponsorship of Hon. Adrian S. Camposagrado, Committee Chairman) and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares and Hon. Joel L. Sayson;

BE IT RESOLVED, to authorize Atty. Virglio T. Teruel, Municipal Mayor in Behalf of the Municipality of Tigbauan to Enter Into A Memorandum of Agreement (MOA) With Central Philippine University (CPU) to Collaborate on Social Development Programs and Other Necessary Support and Cooperation for the Good of the Constituents;

RESOLVED FURTHER, to indicate the Municipality's willingness to avail of the outreach programs and services of the Department and the University in a long term basis through partnership with a commitment to provide necessary support and cooperation for the good of its constituencies;

RESOLVED FINALLY, to forward copies of this resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel and all concerned for their information and/or appropriate action.
