RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ATTY. VIRGILIO T. TERUEL, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN, TO ENTER INTO A CONTRACT TO SELL/DEED OF ABSOLUTE SALE FOR THE PURCHASE OF A PORTION OF LOT NO. 9516/ASSESSOR’S LOT NO. 262 WITH AN AREA OF 1,100 SQUARE METERS COVERED BY TAX DECLARATION NO. 40-0020-006750 LOCATED AT BARANGAY BAYUCO, THIS MUNICIPALITY, AS SITE FOR THE SUPER HEALTH CENTER II UNDER THE HEALTH FACILITIES ENHANCEMENT PROGRAM OF THE DEPARTMENT OF HEALTH, WITH A TOTAL PURCHASE PRICE OF ₱3,300,000.00

WHEREAS, the Health Facilities Enhancement Program (HFEP) of the Department of Health (DOH) serves as the national government’s strategy to provide assistance to government-owned healthcare facilities for the improvement of infrastructure, upgrade of medical equipment, medical transport and acquisition of land for health facility expansion with the main goal of improving the delivery of basic and essential health services to the public;

WHEREAS, the Super Health Centers, under the HFEP, are established all throughout the country to improve access of the Filipino people to government health services during the pandemic and other similar health crises;

WHEREAS, the Local Government Unit of Tigbauan is in need of additional space/lot to accommodate the establishment of the Super Health Center II in the Municipality of Tigbauan;

WHEREAS, Section 444 (vi) of the Local Government Code provides that, *“the Chief Executive shall, upon authorization by the Sangguniang Bayan, represent the municipality in all*

its business transactions and sign on its behalf all contracts and obligations, and such other documents made pursuant to law or ordinance”;



Teruel, for and in behalf of the Municipality of Tigbauan, to enter into a Contract To Sell/Deed of Absolute Sale for the purchase of a portion of Lot No. 9516/Assessor’s Lot No. 262 with an area of 1,100 Square Meters covered by Tax Declaration No. 40-0020-006750 located at Barangay Bayuco, this Municipality, as site for the Super Health Center II under the Health Facilities Enhancement Program of the Department of Health, with a total purchase price of ₱3,300,000.00;
