RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ASSOCIATION OF TIGBAUAN, ILOILO MARKET VENDORS, INC. (ATIMVI) WHERE THE ASSOCIATION AGREES TO PROVIDE NECESSARY SUPPLIES, MATERIALS, MEDICINES, FOOD ITEMS, CONSTRUCTION SUPPLIES AND SIMILAR GOODS TO THE LGU FOR THE PURPOSE OF ASSISTANCE TO VICTIMS OF DISASTERS AND CALAMITIES.

WHEREAS, it is a policy of the State to adopt a disaster risk reduction and management approach that is holistic, comprehensive, integrated, and proactive in lessening the socio-economic and environmental impacts of disasters including change, and promote the involvement and participation of all sectors and all stakeholders concerned at all levels, especially the local community;

WHEREAS, mutual support between and among the local government and its civil society in relation to disaster risk reduction and management in the Municipality of Tigbauan should be promoted;

WHEREAS, the Association of Tigbauan, Iloilo Market Vendors, Inc. (ATIMVI), is a civil society organization of vendors in Tigbauan Public Market;

WHEREAS, the Memorandum of Agreement will be entered into by and between the Local Government of the Municipality of Tigbauan, represented by its Local Chief Executive, **ATTY. VIRGILIO T. TERUEL** and the Association of Tigbauan, Iloilo Market Vendors, Inc. (ATIMVI) represented by its President, **ALBERT Y. VILLOSO**;

WHEREAS, under this agreement, the parties will agree to jointly work together in the event of natural, technological or human-caused disasters and shall undertake commitments;

WHEREAS, the ATIMVI commits that Member-Vendors shall willingly provide necessary supplies, materials, medicines, food items, construction supplies and similar goods to the LGU for the purpose of assistance to victims of disasters;

WHEREAS, ATIMVI further commits that the Member-Vendors shall not take advantage of any price increases that might result from natural, technological or human caused disasters;

WHEREAS, for this agreement, the LGU commits to call upon the ATIMVI for assistance to provide necessary supplies, materials, medicines, food items, construction supplies and similar goods to the LGU in the event of calamities and disasters for the purpose of assistance to the victims of disasters;

NOW, THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, Chairman, Committee on Rules, Ordinances, Resolutions & Legal Matters & Vice Chairman, Committee on Market & Slaughterhouse and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Ana Rowena A. Perera, and Hon. Dyossa Marie Teruñez;


BE IT RESOLVED that the Sangguniang Bayan of Tigbauan hereby grant authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in behalf of the Municipality of Tigbauan to sign and enter into a Memorandum Of Agreement (MOA) with the Association of Tigbauan, Iloilo Market Vendors, Inc. (ATIMVI) where the Association agrees to provide necessary supplies, materials, medicines, food items, construction supplies and similar goods to the LGU for the purpose of assistance to victims of disasters and calamities.

RESOLVED FURTHER, that both parties mutually agree to jointly work together during the advent of natural, technological or human-caused disaster.

RESOLVED FINALLY, that a copy of this resolution be furnished and distributed to all parties involved for their appropriate action.
