RESOLUTION CONFIRMING AND APPROVING THE FOLLOWING: **A.)** CY 2022 SUPPLEMENTAL BUDGET OF BARANGAY LINOBAYAN **B.)** CY 2022 SK SUPPLEMENTAL BUDGET OF BARANGAY BARROC AND **C.)** CY 2022 SK ANNUAL BUDGET OF BARANGAY LANAG, ALL OF THIS MUNICIPALITY.

WHEREAS, the OIC- Municipal Budget Officer on September 6, 2022 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the following: a.) CY 2022 Supplemental Budget of Barangay Linobayan b.) CY 2022 SK Supplemental Budget of Barangay Barroc c.) CY 2022 SK Annual Budget of Barangay Lanag, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

**a.) CY 2022 Supplemental Budget of Barangay Linobayan, to wit:**

*The appropriation of **Brgy. Linobayan** for Supplemental Budget No. 2022-01 embodying Appropriation Ordinance No. 2022-01 in the amount of **P80,000.00** is for the **additional fund for the procurement of Responder Vehicle**, chargeable against its Savings/Surplus-Trust-Fund-BDRRM for 2019-2020;*

**b.) CY 2022 SK Supplemental Budget of Barangay Barroc, to wit:**

*The appropriation of **Brgy. Barroc** for Supplemental Budget No. 2022-01 embodying Appropriation Ordinance No. 2022-01 in the amount of **P580,000.00** is for the **Capital Outlay-improvement of SK Hall-P350,000.00 and rehabilitation of basketball court-P230,000.00**, chargeable against its Savings/Surplus for CY 2019-2020.*

c.) CY 2022 SK Annual Budget of Barangay Lanag, to wit:

The appropriation of **Brgy. Lanag** for the SK Annual Budget CY 2022 in the amount of **P294,500.00** shall be utilized for General Administrative Program in the amount of P59,500.00 and SK Development Empowerment Program in the amount of P235,000.00.

WHEREAS, the OIC- Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned Barangay Annual Budget, SK Annual Budget and Supplemental Budget which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;

RESOLVED, to conform and approve the following: a.) CY 2022 Supplemental Budget Of Barangay Linobayan b.) CY 2022 SK Suppmantal Budget of Barangay Barroc and c.) CY 2022 SK Annual Budget of Barangay Lanag, all of this Municipality.


