RESOLUTION ADOPTING THE EXECUTIVE – LEGISLATIVE AGENDA (ELA) OF THE MUNICIPALITY OF TIGBAUAN, ILOILO FOR THE TERM 2022-2025.

WHEREAS, DILG Memorandum Circular No. 2019-114 dated July 18, 2019 sets for the Clarificatory Guidelines on the Formulation of the Executive-Legislative Agenda (ELA) wherein paragraph 2 of the Preparatory Statement elaborates “that while the ELA represents converging priorities of both the executive and legislative departments agreed to be carried out within their term of office, it should, however, be emphasized that such priorities should come from the LGU vision and the developmental goals, objectives and strategies of the LGUs as embodied in the Comprehensive Development Plan that considered an analysis of the LGU situation;”

WHEREAS, the results of the recently concluded National and Local Elections of 2022 mandate that the new administration shall present the Platform of Governance with supporting Legislative Agenda that will be carried out within their term of office;

WHEREAS, the ELA Team and Secretariat have formulated the ELA from July 6 to September 8, 2022, starting from ELA Steps 1 to 10 and the ELA was presented during the Municipal Development Council [MDC] meeting last September 20, 2022;
