RESOLUTION ENDORSING THE REQUEST OF THE PHILIPPINE COAST GUARD SUB-STATION TIGBAUAN FOR FINANCIAL ASSISTANCE FROM THE OFFICE OF THE PROVINCIAL GOVERNOR, HON. ARTHUR R. DEFENSOR, JR., IN THE AMOUNT OF ONE MILLION PESOS (₱1,000,000.00) FOR THE PROCUREMENT OF ONE (1) UNIT SPEEDBOAT WITH ACCESSORIES

WHEREAS, the Philippine Coast Guard Sub-Station Tigbauan was activated pursuant to Section 1 of PCG General Order No. 413 dated November 12, 2018;

WHEREAS, the Philippine Coast Guard Sub-Station Tigbauan is situated at Barangay Namoccon, Tigbauan, Iloilo which areas of responsibility cover the coastal waters of the Municipality of Tigbauan and Municipality of Guimbal with twenty two (22) coastal barangays and 22.68 nautical miles of coverage of the municipal waters;

WHEREAS, the Philippine Coast Guard Sub-Station Tigbauan has the following floating assets and equipment: one (1) unit Rubberboat-108 (PC420 Rigid Floor Orange L/S, Serial No. XMPD189JG021-108 without Outboard Motor), Two (2) Life Jackets, Two (2) Life Rings, Two (2) Hard Hats, One (1) Unit Computer and One (1) Unit Cellular Phone for communication;

WHEREAS, PCG Sub-Station Tigbauan is in need of one (1) unit speedboat with accessories to be utilized for its patrol operations along its areas of responsibility and coastal barangays;

Arthur R. Defensor, Jr., in the amount of One Million Pesos (₱1,000,000.00) for the procurement of One (1) Unit Speedboat with Accessories;
