RESOLUTION CONFORMING AND ADOPTING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2022-007- “RESOLUTION REALIGNING FINANCIAL ASSISTANCE OF THE MUNICIPAL GOVERNMENT IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) CHARGEABLE AGAINST THE APPROVED ANNUAL INVESTMENT PROGRAM (AIP) C.Y. 2022, 20% NATIONAL TAX ALLOTMENT (NTA) FUND FROM IMPROVEMENT OF MULTI-PURPOSE GYM TO CONSTRUCTION OF BARANGAY MULTI-PURPOSE HALL OF BARANGAY SERMON, MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO”

WHEREAS, the Municipal Development Council thru MDC Resolution No. 2021-01 dated May 7, 2021 approved the Annual Investment Program for C.Y. 2021 of the Municipality of Tigbauan which included the 20% National Tax Allotment (NTA) Fund intended for various infrastructure projects of this Municipality;

WHEREAS, Barangay Sermon, as one of the recipients of said infrastructure projects was provided with Financial Assistance in the amount of Five Hundred Thousand Pesos (P500,000.00) and had identified the proposed Construction of a Covered Gym as its prioritized project;

WHEREAS, the Sangguniang Barangay of Brgy. Sermon negotiated with the lot owner/heirs for the purchase of a lot where the proposed covered gym will be constructed but the negotiation did not materialize;

WHEREAS, considering that the negotiation was unsuccessful, the Sangguniang Barangay decided to realign the P500,000.00 financial assistance from the Construction of a Covered Gym to the Construction of Brgy. Sermon Multi-Purpose Hall;

WHEREAS, the Municipal Development Council's participation is necessary for the approval of the said realignment;
