RESOLUTION APPROVING THE APPLICATION FOR MEMORIAL PARK/CEMETERY PROJECT NO. DP-09-22-01 OF MR. JESSIE G. TERRE WITH OCT NO. H-2262, LOT NO. 11655, WITH AN AREA OF 26,000.00 SQ. M. OUT OF THE TOTAL AREA OF 31,831 SQ. M. MORE OR LESS, CONTAINING ONE THOUSAND EIGHT HUNDRED FORTY SEVEN (1,847) PLOTS LOCATED AT BARANGAY BUENAVISTA, TIGBAUAN, ILOILO

**WHEREAS**, on March 23, 2022, this August Body the Honorable Sangguniang Bayan passed Resolution No. 2022-031-entitled: *“Resolution Approving the Application for Memorial Park/Cemetery Project No. PALC-03-22-001 of Mr. Jessie G. Terre, With OCT No. H-2262, Lot No. 11655, With an Area of 26,000 Sq.M. Out Of Total Area Of 31,831 Sq. M. More Or Less, Containing Four Thousand Four Hundred Forty-Five (4,445) Plots Located At Barangay Buenavista, Tigbauan”*;

**WHEREAS**, the application for Development Permit (Final Approval of Memorial Park/Cemetery) Project No. DP-09-22-01 with OCT No. H-2262, Lot No. 11655, has an area of 26,000 sq. m., with a saleable lots/units containing One Thousand Eight Hundred Forty Seven (1,847) Plots Located at Barangay Buenavista, Tigbauan, Iloilo;

**WHEREAS**, the said final plan submitted was in accordance with pertinent laws, degrees, rules, regulations and had conformed with Article IV, Section 5 of Executive Order No. 648 and its implementing Standards and Guidelines, now the Department of Human Settlements And Urban Developments (DHSUD) of RA 11201;
