RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE SCHOOLS’ DISTRICT OF TIGBAUAN (DEPED SECONDARY AND ELEMENTARY SCHOOLS) TO GRANT FINANCIAL ASSISTANCE IN THE AMOUNT OF SEVENTY THOUSAND PESOS (P70,000.00) FOR THE PURCHASE OF SCHOOL AND OFFICE SUPPLIES, ICT EQUIPMENT AND OTHER PURCHASES/REPAIRS NEEDED BY EACH SCHOOL CHARGEABLE AGAINST THE MOOE OF THE DIFFERENT SCHOOLS (30 SCHOOLS @P70,000=P2,100,000.00), REFLECTED IN THE CY 2022 LOCAL SCHOOL BOARD BUDGET OF THE MUNICIPALITY OF TIGBAUAN UNDER SPECIAL EDUCATION FUND (SEF).

WHEREAS, the Sangguniang Bayan passed Resolution No. 2022-010 entitled: Resolution Adopting Resolution No. 2022-01 of the Local School Board: *“Resolution Approving the Annual Budget of the Local School Board (LSB) of the Municipality of Tigbauan for Calendar Year 2022;”*

WHEREAS, said Memorandum of Agreement shall be made and entered into by, and between the following parties:

- The **MUNICIPALITY OF TIGBAUAN**, a local government unit with principal office address at Tejero St., Tigbauan, Iloilo represented by its Municipal Mayor, **ATTY. VIRGILIO T. TERUEL**, as “First Party”;
- The **ELEMENTARY/SECONDARY SCHOOLS**, in the Municipality of Tigbauan, Iloilo, represented by their respective **PRINCIPAL/HEAD OF SCHOOL**, as “Second Party”.

WHEREAS, under the Local Government Code of 1991 (RA 7160), local government units are mandated to address the needs of its constituencies, and empower the people through direct participation in the affairs of the government, by allowing them the widest possible apace to decide on, initiate, implement, and innovate in development of activities that address their identified needs;

WHEREAS, as a convergence strategy, the Municipality of Tigbauan recognizes and appreciates the efforts and participation of the various DepEd Secondary and Elementary Schools in responding to the needs of their learners;

WHEREAS, the financial assistance in the amount of Seventy Thousand Pesos (P70,000.00) each shall be granted to nineteen (19) elementary schools, two (2) integrated schools and nine (9) secondary schools, this municipality for the total amount of Two Million One Hundred Thousand Pesos (P2,100,000.00);

WHEREAS, the Department of Education (Secondary and Elementary) of the Schools District of Tigbauan requested the release of the above-mentioned amount for the procurement of office and school supplies, equipment and other purchases/repairs needed by the schools;

WHEREAS, premises considered, the parties hereby agree to the following:

The Municipality of Tigbauan:

1. *Shall monitor and evaluate the procurement of office and school supplies, equipment and other purchases/repairs of the concerned school/s.*

The DepEd (Secondary and Elementary) Schools District of Tigbauan

1. *Shall take responsibility in the proper disposition/disbursement of funds for the said procurement in accordance with the Guidelines and COA rules and regulations;*
2. *Shall use the funds of the Municipality of Tigbauan solely for the procurement of the specific items;*
3. *After each assistance, the Accountable Officer shall prepare and submit to the Municipal Government of Tigbauan the Statement of Expenditures duly signed by the Treasurer and verified by COA;*
4. *Shall procure specific items and liquidate all expenses within 30 calendar days upon receipt of funds; and*
5. *Shall return any unexpended balance of funds released and refund any disallowance made by the Municipal Auditor in the course of post audit transaction.*


NOW, THEREFORE, on motion of HON. ANA ROWENA A. PERERA, Vice Chairperson, Committee on Education, Tourism and Civil Service and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson, Hon. Maribeth L. Tupino and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to grant Authority to Atty. Virgilio T. Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan to Sign A Memorandum of Agreement (MOA) With the Schools District of Tigbauan (DepEd Secondary and Elementary Schools) to Grant Financial Assistance in the Amount of Seventy Thousand Pesos (P70,000.00) for the Purchase of School and Office Supplies, ICT Equipment and Other Purchases/Repairs Needed by Each School Chargeable Against the MOOE of the Different Schools (30schools @P70,000=P2,100,000.00), Reflected in the CY 2022 Local School Board Budget of the Municipality of Tigbauan Under Special Education Fund (SEF);

RESOLVED FURTHER, to forward copies of this Resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, to DepEd (Secondary and Elementary) of the Schools District of Tigbauan thru Mr. Edmund Mirasol, District Supervisor and to all concerned for their information and/or appropriate action.
