RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE SCHOOLS DISTRICT OF TIGBAUAN (DEPED SECONDARY AND ELEMENTARY SCHOOLS) TO GRANT FINANCIAL ASSISTANCE IN THE TOTAL AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) FOR THE CONDUCT OF NECESSARY TRAININGS AND SEMINARS CHARGEABLE AGAINST THE LITERACY, VALUES AND ALS PROGRAMS REFLECTED IN THE CY 2022 LOCAL SCHOOL BOARD BUDGET OF THE MUNICIPALITY OF TIGBAUAN UNDER SPECIAL EDUCATION FUND (SEF).

WHEREAS, the Sangguniang Bayan passed a Resolution No. 2022-010– Resolution Adopting Resolution No. 2022-01 of the Local School Board: "Resolution Approving the Annual Budget of the Local School Board (LSB) of the Municipality of Tigbauan for Calendar Year 2022;"

WHEREAS, said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- The **MUNICIPALITY OF TIGBAUAN**, a local government unit with principal office address at Tejero St., Tigbauan, Iloilo represented by its Municipal Mayor, **ATTY. VIRGILIO T. TERUEL**, as "First Party";
- The ELEMENTARY/SECONDARY SCHOOLS, in the Municipality of Tigbauan, Iloilo, represented by their respective PRINCIPAL/HEAD OF SCHOOL, as "Second Party".

WHEREAS, under the Local Government Code of 1991 (RA 7160), local government units are mandated to address the needs of its constituencies, and empower the people through direct participation in the affairs of the government, by allowing them the widest possible apace to decide on, initiate, implement, and innovate in development of activities that address their identified needs;

WHEREAS, on September 23, 2022, the Local School Board passed Resolution No. 2022-01 entitled, "Resolution Realigning the Local School Board Budget for Literacy, Values and ALS Programs in the Amount of Two Hundred Fifty Thousand Pesos (P250,000.00) for Financial Assistance to wit: One Hundred Thousand Pesos (P100,000.00) for Elementary Schools; One Hundred Thousand Pesos (P100,000.00) for Secondary Schools and Fifty Thousand Pesos (P50,000.00) for Literacy/Values/ALS Programs;"

WHEREAS, as a convergence strategy, the Municipality of Tigbauan recognizes and appreciates the efforts and participation of the various DepEd Secondary and Elementary Schools in responding to the needs of their learners and teachers;

WHEREAS, the P250,000-financial assistance is intended for the following: (1) values formation training and other values related activities of the twenty-one (21) elementary schools in the amount of One Hundred Thousand Pesos (P100,000.00); (2) scaling UP PRIMALS Plus Roll Out of the nine (9) secondary schools, in the amount of One Hundred Thousand Pesos (P100,000.00) and graduation of Thirty (30) ALS learners held in the Municipality of Tigbauan on September 18, 2022 and for the procurement of equipment in the amount of Fifty Thousand Pesos (P50,000.00);

WHEREAS, premises considered, the parties hereby agree to the following:

The Municipality of Tigbauan:

1. Shall monitor and evaluate the implementation of the programs/trainings of the concerned school/s.

The DepEd (Secondary/Elementary/ALS) Schools District of Tigbauan

- 1. Shall take responsibility in the proper disposition/disbursement of funds in the implementation of said programs/trainings in accordance with the Guidelines and COA rules and regulations;
- 2. Shall use the funds of the Municipality of Tigbauan solely for the implementation of the specific activity;
- 3. After each assistance, the Accountable Officer shall prepare and submit to the Municipal Government of Tigbauan the Statement of Expenditures duly signed by the Treasurer and verified by COA;
- 4. Shall implement the activity and liquidate all expenses within 30 calendar days upon receipt of funds; and
- 5. Shall return any unexpended balance of funds released and refund any disallowance made by the Municipal Auditor in the course of post audit transaction.
