RESOLUTION INTERPOSING NO OBJECTION TO THE TITLING OF A SCHOOL SITE AT BARANGAY LUBOG, TIGBAUAN, ILOILO (LOT NO. 12737 PSC-49 WHICH WAS TRANSFERRED AND CONVEYED BY WAY OF DONATION) IN THE NAME OF LUBOG PRIMARY SCHOOL, TIGBAUAN, ILOILO.

WHEREAS, Lot 12737 PSC-49 located at Barangay Lubog, Tigbauan, Iloilo with Tax Declaration No. 0141 is declared under the name of Lubog Primary School and is exempted from payment of Real property Tax being actually used as a public school site;

WHEREAS, a Deed of Donation was made and executed by and between the Municipality of Tigbauan, Iloilo, Philippines, represented by Hon. Suzette Tenefrancia-Alquisada, Municipal Mayor, by virtue of Resolution No. 078, Series of 2021 of the Sangguniang Bayan, Tigbauan, Iloilo dated July 21, 2021 in favor of Lubog Primary School located at Brgy. Lubog, this municipality represented by Joy Titular Magbanua as Teacher-in-Charge;

WHEREAS, the Municipality of Tigbauan is the Owner of a certain parcel of land by virtue of a Deed of Donation executed by Hilarion Tabuyog in favor of the Municipality of Tigbauan, situated at Barangay Lubog, Tigbauan, Iloilo known as Lot 12737 PSC-49;

WHEREAS, the Lubog Primary School is on its way to progress and development and is now ready for establishment into a complete elementary school, thus the need to own the lot it is currently occupying;

WHEREAS, the Local Government of Tigbauan is supportive of the needs of the education sector, especially for those young children in the farthest end of this municipality;
