**Resolution No. 2022-151**

RESOLUTION GRANTING AUTHORITY TO ATTY. VIRGILIO T. TERUEL, MUNICIPAL MAYOR, FOR AND IN BEHALF OF THE MUNICIPALITY OF TIGBAUAN TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE SCHOOLS DISTRICT OF TIGBAUAN TO RELEASE THE AMOUNT OF FORTY SEVEN THOUSAND PESOS (P47,000.00) FOR THEIR DISTRICT INNOVATION PROGRAM CHARGEABLE AGAINST THE REPROGRAMMED AMOUNT OF FIFTY FIVE THOUSAND PESOS (P55,000.00) ALLOTTED FOR THE SAID ACTIVITY.

**WHEREAS**, the Sangguniang Bayan passed Resolution No. 2022-010 entitled: “Resolution Adopting Resolution No. 2022-01 of the Local School Board: *“Resolution Approving the Annual Budget of the Local School Board (LSB) of the Municipality of Tigbauan for Calendar Year 2022;”*

**WHEREAS**, in said LSB Special Education Fund (SEF) budget for Calendar Year 2022, the amount of One Million Five Hundred Thousand Pesos (P1,500,000) was appropriated for Sports and Cultural Development Programs but pursuant to LSB Resolution No. 2022-04,

P55,000.00 thereof was reprogrammed to Educational Innovation Showdown Program and this was also approved by this August Body (*per S.B. Resolution No. 2022-105*);

**WHEREAS**, said **Memorandum of Agreement** shall be made and entered into by, and between the following parties:

- The **MUNICIPALITY OF TIGBAUAN**, a local government unit with principal office address at Tejero St., Tigbauan, Iloilo represented by its Municipal Mayor, **ATTY. VIRGILIO T. TERUEL**, as "First Party";
- The **SCHOOLS DISTRICT OF TIGBAUAN**, a government entity in the Municipality of Tigbauan, Iloilo, represented by MR. **EDMUND M. MIRASOL**, Public Schools District Supervisor, as "Second Party"

**WHEREAS**, the FIRST PARTY recognizes and appreciates the efforts and participation of the various DepEd Elementary and Secondary Schools in responding to the needs of its learners;

**WHEREAS**, the SECOND PARTY has requested the release of Forty Seven Thousand Pesos (P47,000) which will be charged against the said P55,000.00 reprogrammed amount in compliance with the DepEd Regional Memorandum No. 753, s. 2022;

**WHEREAS**, premises considered, both parties hereby agree to the following:

*The **FIRST PARTY** shall monitor and evaluate the implementation of the activity in coordination with the concerned office/s;*

*The **SECOND PARTY** shall:*

- 1. Take full responsibility in the proper disposition/disbursement of funds in the implementation of said activity in accordance with the implementing Guidelines and COA rules and regulations;*
- 2. Use the funds of the FIRST PARTY solely for the implementation of the specific activity;*
- 3. After each assistance, the Accountable Officer shall prepare and submit to the FIRST PARTY the Statement of Expenditures duly signed by the Treasurer and verified by COA;*
- 4. Implement the activity and liquidate all expenses within 30 calendar days upon receipt of funds; and*
- 5. Return any unexpended balance of funds released and refund any disallowance made by the Municipal Auditor in the course of post audit transaction.*

Ledesma*), Hon. Giftsie Marie Wali (*counterpart of Hon. Norberto Turalba*), Hon. Anthony Brian Tolato (*counterpart of Hon. Joel L. Sayson*), Hon. Nea First Alcazarin (*counterpart of Hon. Ana Rowena A. Perera*), Hon. John Bert Taronas (*counterpart of Hon. Maribeth L. Tupino*) and Hon. Crisvel Jane Pabustan (*counterpart of Hon. Dyossa Marie Teruñez*);

Teruel, Municipal Mayor, for and in Behalf of the Municipality of Tigbauan to Sign A Memorandum of Agreement (MOA) With the Schools District of Tigbauan to Release Forty Seven Thousand Pesos (P47,000.00) for Their District Innovation Program Chargeable Against the Reprogrammed Amount of Fifty Five Thousand Pesos (P55,000.00) Allotted for the Said Activity;
