Resolution No. 2022-153

RESOLUTION DECLARING A STATE OF CALAMITY IN THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO DUE TO SEVERE TROPICAL STORM “PAENG”

WHEREAS, Section II, Article A of Republic Act 10121 upholds the people’s constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country’s institutional capacity for disaster risk reduction and management and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, Section 6 (a), Rules and Regulations Implementing Republic Act No. 8185, “An Act Amending Section 324 (d) R.A. No. 7160, otherwise known as the Local Government Code of 1991” states that in case of calamity and upon the recommendation of the Local Chief Executive, the Sanggunian concerned shall immediately convene within 24 hours from the occurrence of the calamity and pass a Resolution declaring the area as under a state of calamity;

WHEREAS, on October 31, 2022, the Municipal Disaster Risk Reduction and Management Council submitted to the Sangguniang Bayan Resolution No. 2022-002, entitled: “Resolution Recommending to the Sangguniang Bayan of the Municipality of Tigbauan to Declare the State of Calamity”;

WHEREAS, in a letter also dated October 31, 2022, the Hon. Mayor Atty. Virgilio T. Teruel requested this August Body for the urgent passage of a resolution for the declaration of the state of calamity in the Municipality of Tigbauan due to Severe Tropical Storm “PAENG”;

WHEREAS, Severe Tropical Storm “PAENG”, had brought massive damages and destruction to constituents of Tigbauan particularly damages to houses, infrastructures and other properties, loss of cattle and livestock, and crops such as palay, and loss of power and communications;

WHEREAS, barangays along the shorelines and riverbanks have been intensely battered by strong waves aggravated by rising tides causing thousands of Tigbauanons to evacuate to safe houses and evacuation centers;


NOW THEREFORE, on motion of HON. ADRIAN S. CAMPOSAGRADO, *Chairman, Committee on Disaster, Risk Reduction Management, Science and Technology* and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Joel L. Sayson, Hon. Ana Rowena A. Perera, Hon. Maribeth L. Tupino and Hon. Dyossa Marie Teruñez;

BE IT RESOLVED, to declare the Municipality of Tigbauan, Province of Iloilo Under the State of Calamity Due to Severe Tropical Storm “Paeng”.

RESOLVED FURTHER, to furnish copies of this Resolution to Atty. Virgilio T. Teruel, Municipal Mayor, this municipality, and to all concerned for their information and/or appropriate action.
