RESOLUTION APPROVING THE RESUMPTION OF COCKPIT OPERATIONS OF THE A.P. TENDERO SPORTS ARENA

WHEREAS, in a letter dated October 19, 2022 of Mr. Winifred C. Tendero addressed to the Office of the Sangguniang Bayan of Tigbauan, Mr. Tendero requested for a clearance for the resumption of cockpit operations of A.P. Tendero Sports Arena, Tigbauan, Iloilo;

WHEREAS, the A.P. Tendero Sports Arena has been in operation for several years already within its jurisdiction and has complied with the requirements pertaining thereto;

WHEREAS, because of the nature of cockfighting, the pandemic caused by the Covid-19 virus has put a stop to cockfight operations of legitimate cockpits including that of A.P. Tendero Sports Arena;

WHEREAS, the Inter-agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) issued Resolution No. 154, Series of 2021, allowing the operation of cockpits and traditional cockfighting in areas under Alert Level 2, subject to strict observance of specific protocols;

WHEREAS, the Department of Interior and Local Government (DILG) issued Memorandum Circular No. 2022-003 dated January 19, 2022 enjoining all concerned local government units (LGUs) to undertake necessary actions in the management of cockpits and the conduct of cockfighting activities in areas placed under Alert Level 2 or Lower;

WHEREAS, in order to monitor cockpit operations in the municipality and in accordance with the guidelines set by the IATF-EID and DILG, the Municipal Mayor, Atty. Virgilio T. Teruel issued Executive Order No. 2022-047 on October 28, 2022 creating a Task Force on the Operation of Cockpit and Cockfighting in the Municipality of Tigbauan, Iloilo;

NOW, THEREFORE, on motion of HON. JERRY T. TUARES, Chairman, Committee on Games and Amusement, and duly seconded by Hon. Reynaldo E. Tumabotabo, Hon. Julius T. Ledesma, Hon. Norberto T. Turalba, Hon. Joel L. Sayson, Hon. Dyossa Marie T. Teruñez, and Hon. Maribeth L. Tupino,

BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the Sangguniang Bayan to approve the Resumption of Cockpit Operations of A.P. Tendero Sports Arena;

RESOLVED FURTHER, to forward copies of this Resolution to the Office of the Municipal Mayor, Atty. Virgilio T. Teruel, to Mr. Winfred C. Tendero of A.P. Tendero Sports Arena and to all concerned for their information and/or appropriate action.
