RESOLUTION INTERPOSING NO OBJECTION TO THE REMOVAL/CUTTING OF ONE (1) MAHOGANY TREE IN CONNECTION WITH THE ON-GOING CONSTRUCTION OF THE MULTI-PURPOSE BUILDING INCLUDING PAVEMENT OF PARARA NATIONAL HIGH SCHOOL, BARANGAY PARARA SUR, TIGBAUAN, ILOILO

WHEREAS, in a letter dated November 7, 2022, the Local Chief Executive requested this Sangguniang Bayan for the URGENT passing of a *“Resolution Interposing No Objection To The Removal/Cutting Of One (1) Mahogany Tree In Connection With The On-Going Construction Of The Multi-Purpose Building Including Pavement Of Parara National High School, Parara Sur, Tigbauan, Iloilo”*;

WHEREAS, the Department of Public Works and Highways has been undertaking the Construction (Completion) of Multi-Purpose Building including Pavement at Parara National High School, Barangay Parara Sur, Tigbauan, Iloilo and said project is included in the DPWH FY 2022 Infrastructure Program for the First District;
