**Resolution No. 2022-167**

RESOLUTION CONFORMING AND APPROVING THE CY 2022 SK SUPPLEMENTAL BUDGET OF BARANGAYS DAPDAP, JAMOG, SIPITAN AND BAGACAY THIS MUNICIPALITY.

WHEREAS, the Municipal Budget Officer on November 9, 2022 endorsed to the Office of the Sangguniang Bayan, Tigbauan, Iloilo for review and authorization the CY 2022 SK Supplemental Budgets of Barangays Dapdap, Jamog, Sipitan and Bagacay, this municipality (*as hereunder provided*) to be utilized for projects incidental to the efficient and effective provisions of basic services to the populace:

*The appropriation of **Brgy. Dapdap** for Supplemental Budget No. 2022-01 embodying Appropriation Ordinance No. 2022-01 in the amount of **P90,000.00** is for the **Capital Outlay-Rehabilitation of SK Hall**, chargeable against CY 2021 Retained Operating Surplus of the aforementioned barangay.*

*The appropriation of **Brgy. Jamog** for Supplemental Budget No. 2022-01 embodying Appropriation Ordinance No. 2022-01 in the amount of **P350,000.00** is for the **Capital Outlay-Rehabilitation of SK Office**, chargeable against CY 2018-2020 Retained Operating Surplus of the aforementioned barangay.*

*The appropriation of **Brgy. Sipitan** for Supplemental Budget No. 2022-01 embodying Appropriation Ordinance No. 2022-01 in the amount of **P96,000.00** is for the **Sports Development –Installation of Fiber Glass Board**, chargeable against CY 2021 Retained Operating Surplus of the aforementioned barangay.*

*The appropriation of **Brgy. Bagacay** for Supplemental Budget No. 2022-01 embodying Appropriation Ordinance No. 2022-01 in the amount of **P300,000.00** is for the **Capital Outlay-Improvement of Basketball Court** chargeable against CY 2020-2021 Retained Operating Surplus of the aforementioned barangay.*

WHEREAS, the Municipal Budget Officer had reviewed in advance and endorsed to this August Body the aforementioned SK Supplemental Budgets which show apparent compliance with the provisions of the 1991 Local Government Code and its Implementing Rules and Regulations;

WHEREAS, the review of the foregoing documents/Supplemental budgets likewise show apparent compliance with Section 287 of the Local Government Code Rule XXXVI, Art. 454 (d) of its Implementing Rules and Regulations, Joint Memorandum Circular No. 2011-01 dated April 13, 2011 of the DILG and DBM, Executive Orders, Issuances, Rules and Regulations, relative thereto;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the officials of the implementing local government unit;
