Resolution No. 2022 – 168

RESOLUTION CONFORMING AND APPROVING THE CONDUCT OF S.B. MARATHON SESSIONS FOR THE MONTH OF DECEMBER 2022 TEMPORARILY TRANSFERRING THE REGULAR SESSION DATES TO COMPLY WITH SEC. 52 (A) OF RA 7160.

WHEREAS, Rule VII, Section 14(a) of Resolution No. 2022-077, (*RESOLUTION APPROVING THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO*), provides:

“Section 14. REGULAR SESSION

The minimum number of regular sessions of this Sanggunian shall be "once a week ".

- a.) The regular session shall be held every Monday and shall start promptly at 9:30 in the morning. Provided, however, that if the day falls on a holiday or the session is prevented by insuperable cause the next working day shall be the regular session day.” (Section 52 (a), R.A. 7160)***

WHEREAS, on July 11, 2022 the Sangguniang Bayan passed Resolution No. 2022-083-*“RESOLUTION AMENDING RULE VII, SECTION 14 (a) OF THE S.B.’S INTERNAL RULES OF PROCEDURE PER RESOLUTION NO. 2022-077, BY TRANSFERRING THE REGULAR SESSION EVERY MONDAY TO WEDNESDAY FROM 9:30 IN THE MORNING TO 9:00 O’CLOCK IN THE MORNING;”*

WHEREAS, in order to attend to their hectic schedules and various official and personal activities that they will have during this Christmas Season, which include the S.B. Year-End

Assessment, Planning and Review, the members of this August Body deem it proper to amend the said provision of the Internal Rules of Procedure by holding marathon regular sessions this December 2022 with the following schedules:

WHEREAS, the holding of these marathon sessions, other than the scheduled session dates every Wednesdays (*to include 2 additional session days December 5 (Monday) and December 16 (Friday)*) is in compliance with **Section 52 (a) of R.A. 7160**, to wit:

*“On the first day of the session immediately following the election of its members, the sanggunian shall, by resolution, fix the day, time, and place of its regular sessions. The minimum numbers of regular sessions shall be **once a week** for the sangguniang panlalawigan, sangguniang panlungsod, and **sangguniang bayan**, and twice a month for the sangguniang barangay”;*

WHEREAS, to promote public service and to ensure attendance of the members of the Sangguniang Bayan during sessions, it is imperative that the above schedule be adopted;

NOW, THEREFORE, on motion of HON. JULIUS T. LEDESMA, Vice Chairman, S.B. Committee on Rules, Ordinances, Resolutions and Legal Matters (*under the sponsorship of Hon. Adrian Camposagrado, Committee Chairman*) and duly seconded by Hon. Neri T. Camiña, Hon. Reynaldo E. Tumabotabo, Hon. Norberto T. Turalba, Hon. Jerry T. Tuares, Hon. Joel L. Sayson and Hon. Dyossa Marie T. Teruñez;

RESOLVED, to conform and approve the Conduct of S.B. Marathon Sessions for the Month of December 2022 and Temporarily Transferring the Regular Session Dates to Comply with Sec. 52 (A) of RA 7160;

RESOLVED FURTHER, to furnish copies of this Resolution to Atty. Virgilio T. Teruel, Municipal Mayor, the 52 Barangays of this Municipality, thru the Liga Ng Mga Barangay and all concerned for their information and/or appropriate action.
