RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BARANGAY PEACEKEEPING FORCES (BARANGAY TANODS) IN THE MUNICIPALITY OF TIGBAUAN IN RECOGNITION OF THEIR VALUABLE SERVICE TO THE COMMUNITY, THUS WORTHY TO RECEIVE REWARDS/INCENTIVES IN THE AMOUNT OF ONE THOUSAND PESOS (PHP 1,000.00) FOR EACH TANOD, AND ONE THOUSAND FIVE HUNDRED PESOS (PHP 1,500.00) FOR EACH TANOD COMMANDER CHARGEABLE AGAINST THE BUDGET UNDER OFFICE OF THE MAYOR-DONATIONS.

WHEREAS, in line with the present administration's thrust under Mayor Atty, Virgilio T. Teruel in giving priority to fight against criminality especially fight against illegal drugs and all illegal activities;

WHEREAS, the Municipality of Tigbauan is composed of 52 barangays and has a total of 543 Barangay Tanods;

WHEREAS, these Barangay Tanods have served their respective barangays in a voluntary basis, receiving a minimum honorarium and in return they shall serve as front-liners during disasters and calamities especially during this pandemic;

WHEREAS, the amount although minimal, may serve as encouragement for them to pursue active duty in their respective barangays;

WHEREAS, the amount for financial assistance for the incentives and rewards for Barangay Tanods and Chief Commanders in the amount of P1,000.00 and P1,500.00 respectively, shall be charged against the budget under the Office of the Mayor - Donations;
