RESOLUTION REQUESTING FOR FUNDING ALLOCATION FROM CONGRESSMAN LEX ANTHONY CRIS COLADA, REPRESENTATIVE OF AAMBIS-OWA PARTY LIST FOR THE PRIORITY PROJECTS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO.

WHEREAS, the Municipality of Tigbauan is a component town of the Province of Iloilo with 52 barangays, having a population of 65,245 more or less as of the latest Philippine Statistics Authority census;

WHEREAS, with its rapid expanding population, the Municipality of Tigbauan needs to improve/construct its infrastructure facilities such as the public market and slaughterhouse in order to provide additional revenue collection for the municipality;

WHEREAS, the Local Government Unit has identified the need to improve and develop its road network in different barangays of this municipality, particularly the farm-to-market roads to enhance productivity and to contribute to the social and economic growth of the community especially the farmers;

WHEREAS, the construction/improvement of other infrastructure projects such as multi-purpose halls, water systems, drainage systems and day care and health centers are also essential to help uplift the lives and environment of the growing population in different barangays of this municipality;
