RESOLUTION REQUESTING FOR FUNDING ALLOCATION FROM CONGRESSMAN LEX ANTHONY CRIS COLADA, REPRESENTATIVE OF AAMBIS-OWA PARTY LIST FOR THE PRIORITY PROJECTS OF THE MUNICIPALITY OF TIGBAUAN, PROVINCE OF ILOILO

WHEREAS, the Municipality of Tigbauan is a component town of the Province of Iloilo with 52 barangays, having a population of 65,245 more or less as of the latest Philippine Statistics Authority census;

WHEREAS, with its rapid expanding population, the Municipality of Tigbauan needs to improve/construct its infrastructure facilities specially the farm to market roads to enhance productivity and to contribute to the social and economic growth of the community especially the farmers;

WHEREAS, the Local Government Unit recognizes the need to improve and develop its road network in different barangays, particularly the farm-to-market roads in certain identified areas/barangays as hereunder enumerated;

WHEREAS, the construction of these farm to market roads is essential to help uplift the lives of the growing population;

WHEREAS, due to lack of funds, the Municipality of Tigbauan cannot finance and implement these priority projects hence the need to request for this funding assistance from Congressman Lex Anthony Cris Colada:
